CALLER IS REPORTING THAT A CRUDE OIL SPILL THAT HAS ENTERED A CREEK THAT LEADS TO THE KALAMAZOO RIVER. THIS IS A MAIN LINE INCIDENT WITH AN UNKNOWN CAUSE. THE FAILURE OCCURRED IN A 30" DIAMETER PIPELINE. MATERIAL HAS NOT REACHED THE KALAMAZOO RIVER YET.
