1. GRANTEE: SRC Devices, Inc.  
a division of Sumida Corporation  
Earth City, MO  
(Former grantee: REMetch Corporation)
2. PURPOSE AND LIMITATION:
  - a. This exemption authorizes the transportation in commerce of certain electronic relay devices containing not more than 3.0 grams of metallic mercury each, classed as Consumer commodity, ORM-D, in packagings as specified herein. This exemption provides no relief from any Hazardous Materials Regulation (HMR) other than as specifically stated herein.
  - b. The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR Parts 171 through 180, except as specified in this exemption.
5. BASIS: This exemption is based on the application of REMtech Corporation dated September 18, 2002 submitted in accordance with § 107.109.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES: Packagings prescribed are heat sealed glass vials, containing not more than 3.0 grams of mercury each. The vials are packed for shipment as described in Exhibit A of CP Clare Corporation's application of September 27, 1994.
8. SPECIAL PROVISIONS:
- a. No shipping papers are required for packages covered by the terms of this exemption.
- b. Persons who receive the packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with and a current copy of this exemption is maintained at each facility from which such reoffering occurs.
- c. MARKING - The outside of each package must be marked "Consumer commodity, ORM-D" and "DOT-E 8091". No other markings are required by this exemption.
9. MODES OF TRANSPORTATION AUTHORIZED: Cargo aircraft only, and passenger-carrying aircraft.
10. MODAL REQUIREMENTS: A current copy of this exemption must be carried aboard each aircraft used to transport packages covered by this exemption. The shipper must furnish a current copy of this exemption to the air carrier before or at the time the shipment is tendered.

11. COMPLIANCE:


a. Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by §§ 172.700 through 172.704.

b. No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS: The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (Sections 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incident involving the package and shipments made under the terms of this exemption.
