1. McDonnell Douglas, Saint Louis, Missouri, is hereby granted an exemption from certain provisions of this Department's Hazardous Materials Regulations specified in paragraph 5 below to offer packages prescribed herein of Class C explosives for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the transportation of various Class C explosives in the same outside packaging in quantities greater than those authorized in 49 CFR 173.87, and provides no relief from any regulation other than as specifically stated.

2. BASIS. This exemption is based on an application from McDonnell Douglas dated January 11, 1990 submitted in accordance with 49 CFR 107.103 and the public proceeding thereon.

3. HAZARDOUS MATERIALS (Descriptor and class). Actuating cartridge, explosive; detonating fuze, Class C explosive; electric squibs; explosive cable cutter; explosive power device Class C; explosive release device; fuse, mild detonating metal clad; igniter; and small arms ammunition, - classed as Class C explosives.

4. PROPER SHIPPING NAME (49 CFR 172.101). Appropriate specific shipping name as prescribed in 49 CFR 172.101.

5. REGULATIONS AFFECTED. 49 CFR 173.87.

6. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle.

7. SAFETY CONTROL MEASURES. Packaging prescribed is: innermost packaging consisting of fiberboard containers, metal cans or plastic bags; intermediate packaging consisting of fiberboard boxes or plastic bags containing only items having same shipping description in any one box or bag; outside packaging must be a strong wooden box with adequate cushioning material to prevent dangerous movement of inner packages during transportation.

8. SPECIAL PROVISIONS.

a. Persons who receive packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with, and a current copy of this exemption is maintained at each facility from which such reoffering occurs.


- b. A copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.
- c. Transportation must be by private motor vehicle only.
- d. The outside packaging must bear the EXPLOSIVE C label and be marked with the proper shipping name of each type of device contained within the box.
- e. Loading and unloading of motor vehicles used under this exemption must be by McDonnell Douglas employees trained to handle these types of explosives.
- f. Each carrier transporting materials under the terms of this exemption must hold a "Conditional" or "Satisfactory" safety rating, as prescribed in 49 CFR Part 385.

9. REPORTING REQUIREMENTS. Any incident involving loss of fire, explosion or packaging contents or packaging failure must be reported to the Office of Hazardous Materials Transportation as soon as practicable.
