1. The Ensign-Bickford Company, Simsbury, Connecticut, is hereby granted an exemption from certain provisions of this Department's Hazardous Materials Regulations to offer packages prescribed herein of a high explosive for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the transportation of desensitized PETN in polyethylene bottles overpacked in DOT Specification 12H fiberboard boxes and provides no relief from any regulation other than as specifically stated.
2. BASIS. This exemption is based on an application from Ensign Bickford dated June 6, 1990, submitted in accordance with 49 CFR 107.103 and the public proceeding thereon.
3. HAZARDOUS MATERIALS (Descriptor and class). Desensitized PETN classed as a Class A explosive.
4. PROPER SHIPPING NAME (49 CFR 172.101). High explosive.
5. REGULATION(S) AFFECTED. 49 CFR 173.65.
6. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle.
7. SAFETY CONTROL MEASURES. Packagings prescribed are one gallon capacity polyethylene bottles described on Bercon Packaging, INC. sheet #14:01 dated 5/04/90. Each bottle may not contain more than 5.5 pounds of desensitized PETN. Not more than 9 bottles may be placed in a DOT Specification 12H fiberboard box which must be provided with fiberboard dividers to prevent any unsafe movement of the bottles.
8. SPECIAL PROVISIONS.
 - a. Persons who receive packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with, and a current copy of this exemption is maintained at each facility from which such reoffering occurs.
 - b. A copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.

c. Drivers must have been instructed as to necessary safeguards and proper procedures in the event of unusual delay, fire, or accident.

d. Motor carriers operating under the terms of this exemption must have a "Satisfactory" safety rating as prescribed in 49 CFR Part 385.

9. REPORTING REQUIREMENTS: Any incident involving fire, explosion or loss of packaging contents or packaging failure must be reported to the Associate Administrator for Hazardous Materials Safety as soon as practicable.

10. EXPIRATION DATE. October 31, 1992.
