- 1. <u>GRANTEE:</u> Allied-Signal Safety Restraint Systems, Sterling Heights, MI.
- 2. PURPOSE AND LIMITATION:
 This emergency exemption authorizes the transportation in commerce of certain automotive seat-belt pre-tensioners or seat-belt modules as Class 9 articles that have not yet been examined, classed and approved in accordance with Section 173.56(b) and provides no relief from any regulation other than as specifically stated herein.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR Section 173.56(b).
- 5. <u>BASIS.</u> This emergency exemption is based on Allied Signal Safety Restraint System's application dated March 31, 1995, submitted in accordance with 49 CFR 107.113 and a determination that it is necessary to preclude a serious economic loss.

7. PACKAGING AND SAFETY CONTROL MEASURES:

Seat belt pre-tensioners or seat-belt modules shall be packaged as prescribed in Section 173.166 as last revised on December 29, 1994 and published in Volume 59, No. 249 of the Federal Register on page 67509.

8. SPECIAL PROVISIONS.

- a. Persons who receive the packages covered by this exemption may reoffer them for transportation provided no modifications or changes are made to the packages, all terms of this exemption are complied with and a current copy of this exemption is maintained at each facility from which such reoffering occurs.
- b. Shippers using the packaging covered by this exemption must comply with all provisions of this exemption, and all other applicable requirements contained in 49 CFR Parts 171-180.
- 9. <u>MODES OF TRANSPORTATION AUTHORIZED</u>. Motor vehicle and cargo-only aircraft.
- 10. MODAL REQUIREMENTS: A copy of this exemption must be carried aboard each aircraft or motor vehicle used to transport packages covered by this exemption. In accordance with the provisions of 49 CFR Part 107, Appendix B to Subpart B, paragraph 3, the shipper shall furnish a copy of this exemption to the air carrier before or at the time the shipment is tendered.
- 11. <u>COMPLIANCE</u>. Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by Federal hazardous materials transportation law 49 U.S.C. 5101 <u>et seq.:</u>
 - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by 49 CFR 107.601 et seg., when applicable.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect unless a regulation has been amended making the exemption no longer necessary. 12. REPORTING REQUIREMENTS. The carrier is required to report any incident involving fire, explosion or loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incidents involving the package and shipments made under the terms of this exemption.
