1. **GRANTEE:** Burlington Northern Railroad Company  
Fort Worth, Texas
2. **PURPOSE AND LIMITATION:** This emergency exemption authorizes the transportation, in commerce, of four DOT Specification 111A100W1 tank cars, containing a class 3 material, meeting all DOT requirements except that the tank cars have unapproved fittings. This exemption provides no relief from any regulations other than as specifically stated.
3. **REGULATORY SYSTEM AFFECTED:** 49 CFR Parts 106, 107 and 171-180.
4. **REGULATIONS FROM WHICH EXEMPTED:** 49 CFR 173.31(a) and 179.200-16(a).
5. **BASIS.** This emergency exemption is based on Burlington Northern Railroad Company's application of August 2, 1995, submitted in accordance with 49 CFR 107.113, and a determination that it is necessary to protect life and property.
6. **HAZARDOUS MATERIALS (49 CFR 172.101):**

7. **PACKAGING(S) and SAFETY CONTROL MEASURES:**
  - a. **PACKAGING** - Packaging prescribed are four DOT specification 111A100W1 tank cars, AGEX 1006, TILX 190073, GLNX 3019, and TILX 190076, meeting all DOT specification requirements except that the tank cars have unapproved fittings.

b. **MARKING** - The tank car must be marked "DOT-E 11605" in letters and numerals at least four inches high on a contrasting background above the DOT specification marks.

8. **SPECIAL PROVISIONS.**

a. Shipment of the four tank cars is authorized from Burlington Northern Railroad Company's railyard, Hinton, Iowa, to Transisco Rail Services, Miles City, Montana, a distance of approximately 650 miles utilizing the most direct route available via Burlington Northern Railroad Company.

9. **MODES OF TRANSPORTATION AUTHORIZED.** Rail freight.

10. **MODAL REQUIREMENTS:**

a. The Federal Railroad Administration (FRA) is to be notified if any unusual incident occurs during the movement by contacting the:

11. **COMPLIANCE.** Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by Federal hazardous materials transportation law, 49 U.S.C. Section 5101 et seq:


- All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
- Registration required by 49 CFR 107.601 et seq., when applicable.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS.

a. The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder of this exemption must inform the AAHMS, in writing, of any incident involving the package and shipment made under the terms of this exemption.
