1. **GRANTEE:** Members of the American Pyrotechnics Association
Chestertown, MD.

party status to this exemption.)
2. **PURPOSE AND LIMITATION:** This exemption authorizes the
transportation in commerce of Division 1.3 and 1.4 display
fireworks with igniters (electric matches) attached to
either the fuse or the lift charge. This exemption provides
no relief from any regulation other than as specifically
stated herein.
3. **REGULATORY SYSTEM AFFECTED:** 49 CFR Parts 106, 107 and 171-
180.
4. **REGULATIONS FROM WHICH EXEMPTED:** 49 CFR Part 173.54(1).
5. **BASIS:** This exemption is based on American Pyrotechnics
Association's (APA) application dated April 8, 1998
submitted in accordance with 49 CFR 107.109.
6. **HAZARDOUS MATERIALS (49 CFR 172.101):**

7. PACKAGING AND SAFETY CONTROL MEASURES:

- a. PACKAGING - As required in 49 CFR 173.62.
- b. MARKING Outside packaging must be marked with the EX number assigned to the fireworks (not the igniter) and DOT-E 11685.

8. SPECIAL PROVISIONS:

- a. Fireworks (with igniters attached) covered by this exemption are authorized to be transported only by private motor carrier from place of a firework manufacture or a firework display operator's facility to a firework display site or a storage facility associated with a display site.
- b. Both the fireworks and the igniters must be separately approved and assigned EX numbers in accordance with 49 CFR 173.56.
- c. Report (salute) shells, as defined in APA 87-1, exceeding 3 inches in diameter or containing more than 70 grams (2.5 ounces) of detonating powder may not have igniters attached and are not authorized to be transported under this exemption.
- d. The igniter must be certified by the manufacturer to be thermally stable at 150 degrees Centigrade for 24 hours.
- e. The igniter must be rated by the manufacturer to have a "no fire current" of not less than 0.20 amperes (200 milliamperes) i.e. the match head will not ignite when a current of less than 0.20 amperes is passed through it.
- f. The igniter must be securely attached to the fuse or the lift charge of the firework so as to prevent significant movement of the igniter.
- g. When the igniter is placed directly into the "lift charge" of a firework, it must have a "shroud" over the match head composition.
- h. The leg wires of the igniter must be shorted at all times during transportation.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.10. MODAL REQUIREMENTS:

A copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.

11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. Section 5101 et seq:
- o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Registration required by 49 CFR 107.601 et seq., when applicable.

Each "Hazmt employee", as defined in 49 CFR 171.8 who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by 49 CFR 172.700 through 172.704.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS: The carrier is required to report any incident involving fire, explosion or loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incidents involving the package and shipments made under the terms of this exemption.
