1. GRANTEE: FMC Corporation Philadelphia, PA

- 2. <u>PURPOSE AND LIMITATION</u>: This exemption authorizes the transportation in commerce of no more than 50 pounds of lithium in a non-DOT specification packaging. This exemption provides no relief from any regulation other than as specifically stated herein.
- 3. <u>REGULATORY SYSTEM AFFECTED</u>: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR 173.244 in that a non-DOT specification packaging is authorized.
- 5. <u>BASIS</u>: This exemption is based on the application of FMC Corporation dated April 29, 1997, submitted in accordance with 49 CFR 107.105 and the public proceeding thereon, and an additional letter dated May 26, 1998.
- 6. HAZARDOUS MATERIALS (49 CFR_172.101):

7. PACKAGING AND SAFETY CONTROL MEASURES:

a. <u>PACKAGING</u> - Packaging prescribed is a non-DOT specification bulk metal vessel suitable for lithium and capable of maintaining an internal pressure of argon gas, not exceeding 15 psig. The vessel is constructed of 3/8" steel consistent with the drawing on file with the Office of Hazardous Materials Exemptions and Approvals.

8. SPECIAL PROVISIONS:

- a. Shipments are restricted to private carriage.
- b. <u>MARKING</u> The container must be marked on two opposing sides with "DOT-E 11882" in two inch letters on a contrasting background.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.

10. MODAL REQUIREMENTS:

A copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.

- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. Section 5101 et seq:
 - o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - Registration required by 49 CFR 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in 49 CFR 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by 49 CFR 172.700 through 172.704.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS: The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (49 CFR 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incident involving the package and shipments made under the terms of this exemption.
