1. GRANTEE: Sun Nuclear Corporation  
Melbourne, FL
2. PURPOSE AND LIMITATIONS:
  - a. This special permit authorizes the manufacture, marking, sale and use of non-DOT specification packaging described as a hermetically sealed ionization chamber for the transportation in commerce of the materials authorized by this special permit. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
  - b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce. The safety analyses did not consider the hazards and risks associated with use as a component of another device or other uses not associated with transportation in commerce.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR §§ 173.302a(a)(1), and 175.3 in that the use of a non-DOT specification packaging (ionization chamber) is not authorized except as specified herein.

5. BASIS: This special permit is based on the application of Sun Nuclear Corporation dated April 28, 2006 submitted in accordance with § 107.109.
6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES:

a. PACKAGING - Packaging prescribed is a non-DOT specification metal, inside container, described as a hermetically sealed ionization chamber (radiation detector). The ionization chamber is an integral part of a medical test instrument described as a dose calibrator. Each ionization chamber must be designed and constructed in accordance with Sun Nuclear Corporation Drawing 020130 dated December 4, 1991 and other drawings on file with the Office of Special Permits and Approvals (OHMSPA). The ionization chamber is not equipped with a pressure relief device. Each ionization chamber must conform with the following design criteria:

Construction Material: Welded 6063-T6 aluminum cylinder  
6061-T6 top and bottom plates

Outside Diameter: 5 inches

Gas Volume: 105 cubic inches

Operating pressure: 75 psig

Minimum burst pressure: Four times the design pressure

b. OPERATIONAL CONTROLS -

(1) The ionization chamber must be shipped in a strong outside packaging capable of withstanding a minimum drop test of four feet without breakage of the ionization chamber or rupture of the outside packaging.

(2) If repackaged, packagings used to ship larger equipment containing ionization chambers covered by this special permit must be in strong outside packagings providing equivalent protection for the devices as specified in paragraph 7.b.(1) above.

(3) Emergency response information provided with the shipment, and available via an emergency response telephone number must identify that the receptacles are not fitted with pressure relief devices, and provide appropriate guidance for exposure to fire.

(4) The ionization chamber may only be recharged by Sun Nuclear Corporation personnel at its manufacturing facility.

8. SPECIAL PROVISIONS:

a. In accordance with the provisions of Paragraph (b) of § 173.22a, persons may use the packaging authorized by this special permit for the transportation of the hazardous materials specified in paragraph 6, only in conformance with the terms of this special permit.

b. A person who is not a holder of this special permit, but receives a package covered by this special permit, may reoffer it for transportation provided no modifications or changes are made to the package and it is offered for transportation in conformance with this special permit and the HMR.

c. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.

- d. Each packaging manufactured under the authority of this special permit must be either (1) marked with the name of the manufacturer and location (city and state) of the facility at which it is manufactured or (2) marked with a registration symbol designated by the Office of Hazardous Materials Special Permits and Approvals for a specific manufacturing facility.
- e. A current copy of this special permit must be maintained at each facility where the package is manufactured under this special permit. It must be made available to a DOT representative upon request.
- f. Except when offered for transportation by air:
- (1) Packages covered by this special permit are excepted from labeling requirements of Subpart E of Part 172.
  - (2) Shipments are not subject to the placarding requirements of Subpart F of 49 CFR Part 172.
- g. Packagings permanently marked 'DOT-E 13026', prior to October 1, 2007 may continue to be used under this special permit for the remaining service life of the packaging or until the special permit is no longer valid. Packagings marked on or after October 1, 2007 must be marked 'DOT-SP 13026'.
- h. Shipping papers displaying 'DOT-E 13026' may continue to be used until October 1, 2007, provided the special permit remains valid.
9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle, rail freight, cargo vessel, cargo aircraft only, and passenger-carrying aircraft.
10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each aircraft used to transport packages covered by this special permit. The shipper must furnish a current copy of this special permit to the air carrier before or at the time the shipment is tendered.

11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:

- o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, Parts 171-180.
- o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
- o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.


No person may use or apply this special permit, including display of its number, when the special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)- 'The Hazardous Materials Safety and Security Reauthorization Act of 2005' (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term 'exemption' to 'special permit' and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of

this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
