1. GRANTEE: Schering-Plough Veterinary Operations, Inc.  
Baton Rouge, LA
2. PURPOSE AND LIMITATION:
  - a. This exemption authorizes the transportation in commerce of a flammable liquid approximately 200 feet on a public road, from one Schering-Plough location to another, as essentially not subject to 49 CFR Parts 172 and 173. This exemption provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
  - b. The safety analyses performed in development of this exemption only considered the hazards and risks associated with transportation in commerce.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR Parts 171-180 except as specified herein.
5. BASIS: This exemption is based on the application of Schering-Plough Veterinary Operations, Inc. dated July 24, 2002, submitted in accordance with § 107.105 and the public proceeding thereon.

7. SAFETY CONTROL MEASURES:

a. PACKAGING - Packaging prescribed is a 75 gallon non-DOT specification tank fabricated from type 316 stainless steel. The tanks are fabricated in accordance with the requirements of British Standard 5500. The serial numbers of the tanks are: V-805, V-813 and V-822. The tank must be placed into a steel frame that is securely mounted to the truck for transportation.

b. OPERATIONAL CONTROLS:

(1) Transportation is only authorized between:

Baton Rouge, LA 70814

(2) Only one tank may be transported at one time on the vehicle.

8. SPECIAL PROVISIONS: A current copy of this exemption must be maintained at each facility where the package is offered for transportation.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.

10. MODAL REQUIREMENTS: None as a requirement of this exemption.

11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this exemption and penalties prescribed by the Federal hazardous materials transportation laws 49 U.S.C. 5101 et seq:


- o All terms and conditions prescribed in this exemption and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
- o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this exemption must receive training on the requirements and conditions of this exemption in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this exemption, including display of its number, when the exemption has expired or is otherwise no longer in effect.

12. REPORTING REQUIREMENTS: The carrier is required to report any incident involving loss of packaging contents or packaging failure to the Associate Administrator for Hazardous Materials Safety (AAHMS) as soon as practicable. (Sections 171.15 and 171.16 apply to any activity undertaken under the authority of this exemption.) In addition, the holder(s) of this exemption must inform the AAHMS, in writing, of any incidents involving the package and shipments made under the terms of this exemption.
