# DOT-SP 14273 (FIRST REVISION)

(FOR RENEWAL, SEE 49 CFR § 107.109)

1. GRANTEE: (See individual authorization letter)

## 2. PURPOSE AND LIMITATION:

- a. This special permit authorizes the transportation in commerce of lighters in non-UN Standard packaging without marking the approval number (T number) on the outer package. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein.
- b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
- c. Unless otherwise stated herein, this special permit consists of the special permit authorization letter issued to the grantee together with this document.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171- 180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR §§ 172.102(c)(5) special provision N10 and 173.308 in that non-UN standard outer packaging and outer packages not marked with the approval number (T number) is not authorized except as specified herein.
- 5. BASIS: This special permit is based on the application of Garden State Tobacco d/b/a H.J. Bailey Co. dated October 7, 2005 submitted in accordance with  $\S$  107.105 and the public proceeding thereon.

# 6. HAZARDOUS MATERIALS (49 CFR § 172.101):

#### 7. SAFETY CONTROL MEASURES:

- a. <a href="PACKAGING">PACKAGING</a> Prescribed packaging system having an inner and outer packaging is as follows:
  - (1) Outer packaging is a non-UN Standard multi-wall fiberboard box.
  - (2) Inner packaging consist of various designs of approved cigarette lighters and the sealed inner packaging, referred to as tray lots, used in the original transportation from the manufacturer to the grantee which have been approved by the Associate Administrator for Hazardous Materials Safety.
  - (3) Inner packagings must be securely cushioned to prevent movement within the outer packaging during transport.

#### b. OPERATIONAL CONTROLS -

- (1) The tray lots may not be opened until received at the final destination. Unsealed trays may not be shipped under this special permit.
- (2) No outer packaging may contain more than 300 lighters.
- (3) A transport vehicle may not carry more than 1,500 lighters at any one time during transportation.
- (4) Lighters may not be placed in an outer packaging with other hazardous materials.

## 8. SPECIAL PROVISIONS:

- a. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package or its contents and it is reoffered for transportation in conformance with this special permit and the HMR.
- b. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.
- c. Each outer packaging must be plainly and durably marked with the words "LIGHTERS" in addition to "DOT-SP 14273" on a contrasting background.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor Vehicle.
- 10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et</u> seq:
  - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
  - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
  - o Registration required by  $$107.601 \text{ } \underline{\text{et seq.}}, \text{ when applicable.}$

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety -- OHMSPA, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
