1. <u>GRANTEE</u>: Airgas USA, LLC Cheyenne, WY

## 2. PURPOSE AND LIMITATION:

a. This emergency special permit authorizes the transportation in commerce of a DOT Specification 3AA cylinder containing anhydrous ammonia that developed a leak and is equipped with a Chlorine Institute Kit "A" to prevent leakage during transportation. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.

b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce. The safety analyses did not consider the hazards and risks associated with consumer use, use as a component of a transport vehicle or other device, or other uses not associated with transportation in commerce.

c. No party status will be granted to this special permit.

- 3. <u>REGULATORY SYSTEM AFFECTED</u>: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR § 173.3(e) in that a Chlorine Institute Kit "A" may not be used for anhydrous ammonia, except as provided herein and § 172.301(c) in that the marking requirements are waived.

- 5. <u>BASIS</u>: This emergency special permit is based on the application of Airgas USA, LLC dated March 27, 2013, submitted in accordance with § 107.117 and a determination that it is necessary to prevent significant injury to persons or property.
- 6. HAZARDOUS MATERIALS (49 CFR § 172.101):

## 7. SAFETY CONTROL MEASURES:

a. <u>PACKAGING</u> - Packaging prescribed is a DOT Specification 3AA cylinder which developed a leak. The cylinder is equipped with a Chlorine Institute Kit "A" to prevent leakage during transportation.

b. The cylinder must be braced and blocked to prevent movement during transportation.

8. SPECIAL PROVISIONS:

a. The cylinder will be transported by a motor vehicle owned and operated by Airgas USA, LLC and will be transported one-time, one-way to the Airgas Specialty Products plant in Deer Island, OR.

b. MARKING - The marking requirements of § 172.301(c) are waived.

- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor Vehicle.
- 10. <u>MODAL REQUIREMENTS</u>: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.

- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et</u> seq:
  - All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
  - Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
  - o Registration required by \$ 107.601 et seq., when
    applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) - "The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS</u>: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 Immediate notice of certain hazardous materials incidents, and 171.16 Detailed hazardous Continuation of DOT-SP 15840

materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
