1. GRANTEE: (See individual authorization letter)
2. PURPOSE AND LIMITATION:
  - a. This special permit authorizes the transportation in commerce of compressed nitrogen in a Subsurface Safety Valve (SSSV), a non-DOT specification pressurized mechanical device which is not equipped with a pressure relief device. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
  - b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
  - c. Unless otherwise stated herein, this special permit consists of the special permit authorization letter issued to the grantee together with this document.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 173.301(f) in that a cylinder filled with a gas and offered for transportation must be equipped with one or more pressure relief devices and § 173.302a in that a DOT specification cylinder is required, except as provided herein.

5. BASIS: This special permit is based on the application of Baker Hughes Oilfield Operations Inc. dated January 13, 2016 submitted in accordance with § 107.109 and additional information submitted November 8, 2016 and August 2, 2019.
6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES:

a. PACKAGING:

(1) Prescribed packaging is a Subsurface Safety Valve (SSSV), a non-DOT specification pressurized mechanical device that provides emergency flow control of undersea oil wells.

(2) The SSSV pressure system has a maximum water capacity 78 cubic inches and is charged to a maximum pressure of 10,000 psig.

(3) The SSSV is not equipped with a pressure relief device.

(4) The SSSV complies with the design calculations, drawings, and material specifications submitted with the Baker Hughes Oilfield Operations Inc. application for special permit on file with the Office of Hazardous Materials Safety Approvals and Permits Division.

b. MARKING: The SSSV must be permanently and legibly marked "DOT-SP 15863".

c. OPERATIONAL CONTROLS:

(1) The SSSV pressure system is charged with a maximum quantity of 2.0 pounds of compressed nitrogen.

(2) Each SSSV must be packed in strong outer packaging to provide protection during transportation.

(3) Emergency response information provided with the shipment and available via an emergency response telephone number must indicate that the devices are not fitted with pressure relief devices and provide appropriate guidance in case devices are exposed to fire.

8. SPECIAL PROVISIONS:

a. Under the terms of this special permit, the grantee may only offer hazardous materials (i.e., the grantee is not authorized as a carrier).

b. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package and it is reoffered for transportation in conformance with this special permit and the HMR.

c. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle, cargo aircraft, passenger aircraft, cargo vessel, and rail freight.

10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each cargo vessel, aircraft, or motor vehicle used to transport packages covered by this special permit. The shipper must furnish a copy of this special permit to the air carrier before or at the time the shipment is tendered.

11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:

o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.

- o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
- o Registration required by § 107.601 et seq., when applicable.


Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 Immediate notice of certain hazardous materials incidents, and 171.16 Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
