1. GRANTEE: E.I. DuPont de Nemours & Company, Inc.

2. PURPOSE AND LIMITATION:
 - a. This special permit authorizes two transportation movements in commerce of a UN Specification T22 portable tank that was filled past its required periodic inspection date. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
 - b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
 - c. No party status will be granted to this special permit.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 173.32(e) in that a portable tank may not be filled and offered for transportation after a prescribed periodic test has become due, except as provided herein.
5. BASIS: This special permit is based on the application of E.I. DuPont de Nemours & Company, Inc. dated July 18, 2013 and additional information November 18, 2013 submitted in accordance with § 107.105 and the public proceeding thereon.

7. SAFETY CONTROL MEASURES:

- a. PACKAGING - The prescribed packaging is a UN Specification T22 portable tank which meets all the requirements of the HMR except it was filled and transported after the expiration of the periodic inspection date. The identification number of the portable tank is EURU060010-8. The portable tank must be in accordance with drawings on file with the Approval and Permits Division.
- b. Testing-
 - (1) The authorized portable tank must be leakage test prior to being offered for transportation.
 - (2) The authorized portable tank must be given an external visual inspection in accordance with § 180.605(g) prior to being offered for transportation.
- c. OPERATIONAL CONTROLS -
 - (1) The portable tank is authorized for highway transportation from Keehn Service Corporation in Coatesville, PA to Inchen Corporation in Rock Hill, SC for unloading only.
 - (2) Once unloaded, the portable tank is authorized for highway transportation from Inchen Corporation in Rock Hill, SC to DuPont's Niagara Falls, NY facility for preparation for testing and inspection.

- (3) Conformation of the inert gas blanket must be verified before the portable tank is offered for transportation.
- (4) The portable tank may not be loaded for transportation until the required tests and inspections in Part 180 are completed.
- (5) This special permit is voided once the authorized transportation is complete.

8. SPECIAL PROVISIONS:

a. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package and it is reoffered for transportation in conformance with this special permit and the HMR.

b. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor Vehicle.

10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.

11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:

- o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
- o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
- o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 Immediate notice of certain hazardous materials incidents, and 171.16 Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
