2. PURPOSE AND LIMITATION:

- a. This special permit authorizes the transportation in commerce in the U.S. only of certain hazardous materials by 14 CFR Part 133 Rotorcraft External Load Operations, transporting hazardous materials attached to or suspended from an aircraft, without being subject to certain hazard communication requirements, quantity limitations, packaging and loading and storage requirements. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
- b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
- c. No party status will be granted to this special permit.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR §§ 172.200 and 172.204(c)(3), in that shipping papers are waived, § 172.301(c) in that certain marking requirements are waived, Part 173 in that certain packaging requirements are waived, and § 175.75 in that alternative stowage is authorized.

5. <u>BASIS</u>: This special permit is based on the application of ManuIwa Airways, Inc. dba Volcano Helicopters dated November 17, 2023, submitted in accordance with § 107.109.

6. HAZARDOUS MATERIALS (49 CFR § 172.101):

7. SAFETY CONTROL MEASURES:

- a. <u>PACKAGING</u>: Prescribed packaging is the manufacturer's original packaging or a packaging of equal or greater strength and integrity. Compatibility and effectiveness of all packaging must, at a minimum, meet the requirements of 49 CFR 173.24.
- b. Batteries must have their terminals insulated to prevent short circuits.
- c. Propane must be packaged in DOT 4BW240, or other UN approved cylinders. The propane cylinders must be transported in approved netting in accordance with the manufacturer's instructions.

8. <u>SPECIAL PROVISIONS</u>:

- a. All packages must be blocked and braced to prevent movement.
- b. Materials transported by external load must comply with the safety controls specified in this section.

- c. This special permit does not grant the authority to use foreign-controlled airspace or airports outside the United States.
- d. The marking requirements of 49 CFR 172.301(c) are waived.
- e. The requirements for shipping papers are waived.
- f. Each outer packaging must be properly marked and labeled for the hazardous materials contained within.
- g. Alternative pilot-in-command notification procedures for 49 CFR Part 175.33, may be established subject to the written approval of the FAA Office of Hazardous Materials Safety.
- 9. <u>MODES OF TRANSPORTATION AUTHORIZED</u>: Rotorcraft External Load Operations. Cargo-only Aircraft.

10. OPERATIONAL REQUIREMENTS:

- a. This special permit does not waive any FAA airworthiness requirements or the need to obtain other required FAA authorizations.
- b. A current copy of this special permit must be carried aboard each aircraft used to transport materials covered by this special permit.
- c. <u>Authorized aircraft</u>: Aircraft used under this special permit must be authorized as part of an FAA 14 CFR Part 133 Operating Certificate.
- d. <u>Operations manual</u>: FAA 14 CFR Part 133 operations must be conducted in accordance with conditions and limitations specified in the certificate holder's FAA-approved Rotorcraft Load Combination Flight Manual (RLCFM) and Hazardous Material Safety Mitigation Plan.
- e. <u>Authorized persons aboard aircraft</u>: No person may be carried on the aircraft other than as authorized by 14 CFR 133.35.
- f. Operations under the terms of this special permit are only authorized to be conducted in the U.S.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:

- o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
- o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
- o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS</u>: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
