1. <u>GRANTEE</u>: 3M Chemical Operations, LLC Saint Paul, MN

### 2. PURPOSE AND LIMITATION:

- a. This special permit authorizes the transportation in commerce of specification DOT 4BW cylinders containing certain toxic gases without pressure relief devices. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
- b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
- c. No party status will be granted to this special permit.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR § 173.301(f) in that DOT specification cylinders must be equipped with one or more pressure relief devices, except as specified herein.
- 5. <u>BASIS</u>: This special permit is based on the application of 3M Company dated April 26, 2021, submitted in accordance with § 107.109.

### 7. SAFETY CONTROL MEASURES:

- a. <u>PACKAGING</u>: Packagings prescribed are Specification DOT 4BW cylinders for the transportation in commerce of the compressed gases listed in paragraph 6. The cylinders meet all requirements of the applicable specifications except that they are not equipped with pressure relief devices (PRDs) as prescribed in § 173.301(f).
- b. <u>MARKING</u>: Each cylinder must be marked with "DOT-SP 16530" in addition to the specification markings as required in § 173.35(f) and § 178.61(o).
- c. <u>REQUALIFICATION</u>: Each cylinder must be requalified in accordance with § 180.209 as prescribed for Specification DOT 4BW cylinders.

# d. <u>OPERATIONAL CONTROLS</u>:

- (1) The pressure in the cylinder at 55 °C (131 °F) may not exceed the marked service pressure of the cylinder. Sufficient outage must be provided so that the cylinder will not be liquid full at any temperature up to and including 55 °C (131°F).
- (2) Each cylinder with a valve must be equipped with a protective metal cap, other valve protection device, or an overpack which is sufficient to protect the valve from breakage or leakage resulting from a drop of 2.0 m (7 ft.) onto a non-

yielding surface, such as concrete or steel. Impact must be at an orientation most likely to cause damage.

- (3) The materials of construction for the cylinder, valves, plugs, outlet caps, luting, and gaskets must be compatible with each other and with the lading.
- (4) Emergency response information provided with the shipment and available via an emergency response telephone number must indicate that the cylinders are not fitted with pressure relief devices and provide appropriate guidance in case of fire.

### 8. SPECIAL PROVISIONS:

- a. Under the terms of this special permit, the grantee may only offer hazardous materials (i.e., the grantee is not authorized as a carrier).
- b. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package and it is reoffered for transportation in conformance with this special permit and the HMR.
- c. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.
- 9. <u>MODES OF TRANSPORTATION AUTHORIZED</u>: Motor vehicle, rail freight, and cargo vessel.
- 10. <u>MODAL REQUIREMENTS</u>: A current copy of this special permit must be carried aboard each cargo vessel or motor vehicle used to transport packages covered by this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
  - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
  - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
  - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) — "The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS</u>: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
