1. GRANTEE: Veolia ES Technical Solutions, L.L.C.
Lombard, IL
2. PURPOSE AND LIMITATION:
 - a. This special permit authorizes the one-time transportation in commerce of certain Division 1.3G articles from the Yuba County Sherriff's Department located in Olivehurst, CA to Veolia ES Technical Solutions, L.L.C.'s disposal facility located in Sauget, IL. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
 - b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
 - c. No party status will be granted to this special permit.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 173.21(b) in that offering forbidden explosives is not authorized, §§ 173.51, 173.54(a), and 173.56(b) in that explosives must be tested, classed, and approved, and § 172.320 in that packages must be marked with EX number prior to initial transportation, except as specified herein.

5. BASIS: This special permit is based on the application of Veolia ES Technical Solutions, L.L.C. dated August 5, 2015 submitted in accordance with § 107.105 and the public proceeding thereon.
6. HAZARDOUS MATERIALS (49 CFR § 172.101):

*The 37 article types are on file with the Office of Hazardous Materials Safety Approvals and Permits Division (OHMSAPD). Only the articles and quantity of each article specified in Attachment A to the application dated August 5, 2015 and on file with the OHMSAPD may be transported under the terms of this special permit.

7. SAFETY CONTROL MEASURES:

a. PACKAGING -

(1) Inner Packaging - Bags, anti-static plastic, each containing one (1) article.

(2) Outer Packaging - UN 1A2 Steel drums containing inner packagings with sufficient cushioning (e.g., vermiculite) to prevent movement or contact between individual articles during transport.

b. OPERATIONAL CONTROLS -

(1) The carrier of packages transported under the terms of this special permit must hold a valid Hazardous Materials Safety Permit issued by the Federal Motor Carrier Safety Administration. Only private or contract carriage is authorized under the terms of this special permit.

(2) The transport motor vehicle shall remain locked and secured at all times, and all operations must be conducted in conformance with the carrier's transportation security plan.

8. SPECIAL PROVISIONS:

a. Transportation is only authorized from the Yuba County Sherriff's Department located at 1482 Sky Harbor Drive, Olivehurst, CA to Veolia ES Technical Solutions, L.L.C.'s disposal facility located at 7 Mobile Avenue, Sauget, IL. Once the hazardous materials covered under the terms of this special permit are delivered to the disposal facility, further transportation under the terms of this special permit is prohibited.

b. A current copy of this special permit must be maintained at the facility where the package is offered for transportation, and in the motor vehicle during transport.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.

10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.

11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:

- o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
- o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
- o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
