1. <u>GRANTEE</u>: Department of Defense

#### 2. PURPOSE AND LIMITATIONS:

- a. This emergency special permit authorizes the transportation in commerce of certain fuzes assigned Compatibility Groups (CG) S and D, on the same motor vehicle with certain Division 1.1, 1.2, 1.3, 1.4 or 1.5 materials. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
- b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce.
- c. No party status will be granted to this special permit.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR § 171.25(b)(1), § 173.59, §§ 177.835(g), 177.848(f), and 177.848(g) in that explosives not authorized on the same motor vehicle may be transported together.

5. <u>BASIS</u>: This emergency special permit is based on the application of Department of Defense dated May 26, 2022 and submitted in accordance with § 107.109.

## 7. SAFETY CONTROL MEASURES:

- a. <u>PACKAGING</u>: The individual articles shall be packaged in accordance with their respective EX approvals.
- b. <u>TESTING</u>: All articles shall be tested and approved in accordance with § 173.56.

## c. OPERATIONAL CONTROLS:

- (1) Material must be shipped in support of deployed military personnel, under the direction of the Department of Defense and in accordance with all applicable Defense Transportation regulations.
- (2) Material must be shipped by Department of Defense authorized Ammunition and Explosives carriers meeting the performance criteria of the Military Freight Traffic Rules Publication 1 (MFTURP\_1).

(3) Loads must be segregated and containers stuffed according to IMDG requirements and based on the data from the Conventional Ammunition Packaging and Unit Load Data Index (CAPULDI).

### 8. SPECIAL PROVISIONS:

- a. A person who is not a holder of this special permit, but receives a package covered by this special permit, may reoffer it for transportation provided no modification or change is made to the package and it is offered for transportation in conformance with this special permit and the HMR.
- b. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.
- 9. <u>MODES OF TRANSPORTATION AUTHORIZED</u>: Motor vehicle, rail freight and cargo vessel.
- 10. <u>MODAL REQUIREMENTS</u>: A current copy of this special permit must be carried aboard each cargo vessel, or motor vehicle used to transport packages covered by this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
  - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
  - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
  - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term

"exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS</u>: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
