1. GRANTEE: National Aeronautics and Space Administration
Washington, DC
2. PURPOSE AND LIMITATION:
 - a. This special permit authorizes the transportation in commerce of explosives contained in spacecraft by motor vehicle. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
 - b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
 - c. No party status will be granted to this special permit.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR §§ 172.300 and 172.400 in that marking and labeling of the packages contained within Crew Module are not required, § 173.62 in that non-specification packaging is authorized as described herein, and § 173.56(b) in that the explosive article is not approved.
5. BASIS: This special permit is based on the application of National Aeronautics and Space Administration dated December 2, 2020, submitted in accordance with § 107.109.

7. SAFETY CONTROL MEASURES:

a. PACKAGING: The detonating fuzes (that were previously approved under EX2006090083 and EX1998010090) are installed in the Ascent Abort 2 (AA-2) Crew Module. The Crew Module shall be securely attached to a trailer as described in the application on file with the Office of Hazardous Materials Safety Approvals and Permits Division.

b. OPERATIONAL CONTROLS:

(1) Transportation is authorized for one-way shipments within the continental US between NASA Centers or contractor locations.

(2) The Crew Module must be shipped secured to the transport trailer as described in the Ascent Abort 2(AA-2) Crew Module (DM), Separation Ring (SR) and Crew Module/Separation Ring (CSR) Transportation Plan.

(3) The transport vehicle must be attended at all times by a driver. Drivers must be trained in the dangers of the hazardous materials and measures to be taken in the event of an accident or emergency.

8. SPECIAL PROVISIONS:

a. Under the terms of this special permit, the grantee may only offer hazardous materials (i.e., the grantee is not authorized as a carrier).

b. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or

change is made to the package and it is reoffered for transportation in conformance with this special permit and the HMR.

c. The Crew Module transport vehicle must be marked "DOT-SP 20618" on two opposite sides in letters at least 2 inches in height on the contrasting background.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.
10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.
11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
 - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) – "The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous

materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
