1. <u>GRANTEE:</u> (See individual authorization letter)

2. <u>PURPOSE AND LIMITATION</u>:

a. This special permit authorizes the transportation in commerce of packages with limited quantities of hazardous materials with a reduced size limited quantity marking that is placed either on or adjacent to the package tracking or shipping label. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.

b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.

c. Unless otherwise stated herein, this special permit consists of the special permit authorization letter issued to the grantee together with this document.

- 3. <u>REGULATORY SYSTEM AFFECTED</u>: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR § 172.315(a)(2) in that the limited quantity marking is less than 100 mm on a side regardless of the size of the packaging.
- 5. <u>BASIS</u>: This special permit is based on the application of New Avon Company dated February 10, 2021, submitted in accordance with § 107.105 and the public proceeding thereon, and additional information submitted by Walmart Inc. dated February 18, 2025.

6. <u>HAZARDOUS MATERIALS (49 CFR 172.101)</u>:

7. <u>PACKAGING</u>: As required by the HMR.

8. <u>SPECIAL PROVISIONS</u>:

a. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package and it is reoffered for transportation in conformance with this special permit and the HMR.

b. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.

c. Each limited quantity marking must be a minimum of 50 mm on each side and placed either on or adjacent to the package tracking or shipping label. The special permit number marking required by 49 CFR 172.301(c) must be marked on the same surface of the package as the tracking or shipping label.

d. For transportation via vessel, the reduced size marking is not authorized for use on the outside of an overpack.

e. Multiple limited quantity items may be combined into one outer package for transportation under the terms of this special permit. Each outer package may not exceed 30 kg gross weight.

f. For transportation via vessel, use of this special permit is for domestic cargo vessel transport only. International transportation and ferry vessel operations are not authorized.

9. <u>MODES OF TRANSPORTATION AUTHORIZED</u>: Motor vehicle, rail freight, and domestic cargo vessel.

- 10. <u>MODAL REQUIREMENTS</u>: A current copy of this special permit must be carried aboard each cargo vessel used to transport packages covered by this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
 - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 <u>et seq</u>., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) — "The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS</u>: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this

special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
