1. <u>GRANTEE:</u> Veolia Es Technical Solutions, L.l.c. Boston, MA

2. PURPOSE AND LIMITATION:

a. This special permit authorizes the one-time, one way transportation in commerce of unapproved explosives originating at Aberdeen Proving Ground and transported to Veolia's waste incinerator for final disposal located in Sauget, Illinois by dedicated motor vehicle only. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.

b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.

c. No party status will be granted to this special permit.

- 3. <u>REGULATORY SYSTEM AFFECTED</u>: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR 173.21(b) in that offering forbidden explosives as defined in §173.54 for transportation is not authorized; 49 CFR 173.51 in that offering for transportation or the transport of an explosive material unless it has been tested and classed and approved by the Associate Administrator is not authorized; 49 CFR 173.54(a) in that an explosive that has not been approved in accordance with §173.56 shall not be offered for

transportation or transported and 49 CFR § 173.56(b) in that no person may offer a new explosive for transportation unless that person has had the material examined by an authorized explosives testing agency, classed, and approved by the Associate Administrator.

- 5. <u>BASIS</u>: This special permit is based on the application of Veolia Es Technical Solutions, LLLC dated June 29, 2021 submitted in accordance with § 107.105 and the public proceeding thereon.
- 6. HAZARDOUS MATERIALS (49 CFR 172.101):

*Only water or oil-desensitized explosive materials as described in the application dated June 29, 2021 and on file with the Office of Hazardous Materials Safety may be transported under the terms of this special permit.

7. SAFETY CONTROL MEASURES:

a. <u>PACKAGING</u> This classification is only valid when the explosive substances are diluted with water or corn oil to the level specified in the application dated June 29, 2021 and on file with the Office of Hazardous Materials Safety and package in accordance with §173.201.

b. OPERATIONAL CONTROLS:

(1) Transportation will be performed by Tri-State Motor Transit Co.

(2) The carrier of packages transported under the terms of this special permit must hold a valid Hazardous Materials Safety Permit issued by the Federal Motor Carrier Safety Administration

(3) Transportation is only authorized one-time from Aberdeen Proving Ground military facility located in Aberdeen, Maryland to Veolia ES Technical Solutions, LLC's disposal facility located in Sauget, IL for final disposal. Once the hazardous materials covered under the terms of this special permit are delivered to the disposal facility, further transportation under the terms of this special permit is prohibited.

(4) No type of oxidizer, fuel, flammable solid or combustible device or item may be transported in the same motor vehicle as packages covered under the terms of this special permit.

(5) While in transportation, the cargo carrying portion of the vehicle shall be locked and secured at all times.

(6) Transportation must be completed in the shortest time-frame possible while at all times adhering to all federal, state and local regulations relative to the operation of a commercial motor vehicle on a public highway. To the extent possible, transportation must be conducted so as to avoid rush-hour traffic and avoid high density traffic.

(7) The appropriate Office of Hazardous Materials Safety region must be notified at least 48 hours in advance of any shipment.

(8) A statement must be provided to the U.S. DOT when the shipment arrives at Veolia ES Technical Solutions, LLC's disposal facility located in Sauget, IL.

8. SPECIAL PROVISIONS:

a. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.

- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.
- 10. <u>MODAL REQUIREMENTS</u>: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.

- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
 - All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 et seq., when
 applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)—"The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS</u>: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator
