1. <u>GRANTEE</u>: Spaceflight, Inc.

Seattle, WA

2. <u>PURPOSE AND LIMITATION</u>:

- a. This special permit authorizes the transportation in commerce of prototype or low production lithium ion batteries contained in equipment (spacecraft). This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
- b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
- c. No party status will be granted to this special permit.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR § 173.185(a)(1) in that each lithium battery need not be of the type proven to meet the criteria in Part III, subsection 38.3 of the UN Manual of Tests and Criteria.
- 5. <u>BASIS</u>: This special permit is based on the application of Spaceflight, Inc. dated December 15, 2021 submitted in accordance with § 107.105 and the public proceeding thereon.

^{*}Only prototype and low production lithium ion batteries contained in equipment may be offered for transportation under the terms of this special permit. ("Low production" is defined as a production run of no more than 100 cells or batteries annually of a particular type.) Each different battery type must comply with all the conditions of this special permit prior to being offered for transportation.

7. SAFETY CONTROL MEASURES:

a. OPERATIONAL CONTROLS:

- (1) This special permit is valid only for transportation of lithium ion batteries contained in the following equipment as identified in Spaceflight, Inc.'s December 15, 2021 application on file with the Office of Hazardous Materials Safety (OHMS):
 - (i) The number of spacecraft types as specified in the application, which require a special permit.
 - (ii) The Spaceflight, Inc.'s proprietary aerospace hardware in which a battery of a nominal 460 Wh comprised of Panasonic NCR18650B cells (8S1P) and a battery of a nominal 41.44 Wh comprised of Shenzhen DTP140743 cells (8S2P) are installed.
 - (iii) A variant of the Spaceflight, Inc.'s proprietary aerospace hardware in which a battery of a nominal 317.52 Wh comprised of Samsung INR21700-40T cells (9S1P) and a battery of a nominal 70.56 Wh comprised of Samsung INR21700-50E cells (1S4P) are installed.
- (2) The number of batteries and the total energy capacity in each spacecraft is as described in Spaceflight, Inc.'s December 15, 2021 application on file with the OHMS.

- (3) The batteries must be equipped with a means of preventing dangerous reverse current flow for cells and battery modules connected in parallel.
- (4) No more than one spacecraft is permitted within a package.
- (5) The spacecraft must be constructed to prevent against accidental operation during transport.

b. TESTING REQUIREMENTS:

- (1) Each cell in the batteries within spacecraft including those integrated on and affixed to the Spaceflight, Inc. proprietary aerospace hardware must be a type that has passed the required tests in accordance with the UN Manual of Tests and Criteria, 5th or 6th Revised Edition, as appropriate as in the December 15, 2021 application.
- (2) Each battery contained in equipment may not have passed the tests in accordance with the UN Manual of Tests and Criteria, 6th Revised Edition except for one battery, which has passed the tests as described in the Spaceflight, Inc.'s December 15, 2021 application.
- c. <u>PACKAGING</u>: The spacecraft bus, which houses the spacecraft, must have been designed to handle the rigors of operating in outer space. The spacecraft bus is assembled as follows:
 - (1) The spacecraft integrated on and affixed to the Spaceflight, Inc.'s proprietary aerospace hardware must be wrapped in electrostatic discharge (ESD) material. The ESD-wrapped Spaceflight, Inc. hardware must be placed in custom-made containers constructed of marine-grade wood with fiberglass-wrapped wood top and side panels and then on skid bases to dampen road inputs.
 - (2) The batteries contained in equipment must be protected from short-circuiting while in transportation.
- d. <u>MARKING</u>: Each package prepared under the provisions of this special permit must be plainly marked with the permit number "DOT-SP 21317".

8. SPECIAL PROVISIONS:

a. Under the terms of this special permit, the grantee may only offer hazardous materials (i.e., the grantee is not authorized as a carrier).

- b. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package or its contents and it is reoffered for transportation in conformance with this special permit and the HMR.
- c. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.
- 9. <u>MODES OF TRANSPORTATION AUTHORIZED</u>: Motor vehicle.
- 10. <u>MODAL REQUIREMENTS</u>: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
 - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) — "The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS</u>: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this

special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
