1. GRANTEE: Pollution Control Inc.
Little Rock, AR
2. PURPOSE AND LIMITATION:
 - a. This special permit authorizes the transportation in commerce for the purpose of disposal of an explosive for the that has not been examined and classified in accordance with 49 CFR 173.56(b). This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
 - b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
 - c. No party status will be granted to this special permit.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 172.320 in that the EX-number is not required to be marked on the package and § 173.56(b) in that the explosive has not been examined and classified.
5. BASIS: This special permit is based on the application of Pollution Control Inc. dated January 10, 2023, submitted in accordance with § 107.105 and the public proceeding thereon.

7. SAFETY CONTROL MEASURES:a. PACKAGING:

- (1) Inner packaging: A plastic bag containing not more than 770 grams of substance.
- (2) Intermediate packaging: A plastic bag containing the filled inner packaging.
- (3) Outer packaging: UN 4G fiberboard box (at the Packing Group II level), containing not more than one (1) filled inner packaging (packaged in one intermediate plastic bag) surrounded on all sides and with all void spaces filled with foam cushioning as dunnage.

b. OPERATIONAL CONTROLS:

- (1) The motor carrier transporting the package under the terms of this special permit must have a "Satisfactory" safety rating as prescribed in 49 CFR Part 385.
- (2) Transportation is only authorized from 1100 Centre Parkway, Atlanta, GA to General Dynamics OTS Munition Services, 4147 County Road 180, Carthage, MO for the purpose of disposal.
- (3) Only one package is authorized to be transported under the terms of this special permit.
- (4) No other hazardous materials may be in the same motor vehicle as the hazardous material authorized under this special permit.
- (5) The package may not be elevated more than five feet above the ground at any time during handling or transportation.

(6) Movement must be conducted on highways. Residential areas must be avoided to the extent possible.

8. SPECIAL PROVISIONS:

a. Under the terms of this special permit, the grantee may only offer hazardous materials (i.e., the grantee is not authorized as a carrier).

b. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package and it is reoffered for transportation in conformance with this special permit and the HMR.

c. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle.

10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.

11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:

- o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
- o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
- o Registration required by § 107.601 et seq., when applicable.

Each “Hazmat employee”, as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) —“The Hazardous Materials Safety and Security Reauthorization Act of 2005” (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005),

amended the Federal hazardous materials transportation law by changing the term “exemption” to “special permit” and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. **REPORTING REQUIREMENTS:** Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
