1. <u>GRANTEE</u>: J & M Alaska Air Tours, Inc. d.b.a. Alaska Air Transit Anchorage, AK FAA Certificate Number: HVUA864E (Part 135)

### 2. <u>PURPOSE AND LIMITATION</u>:

a. This emergency special permit authorizes the transportation in commerce of certain Class 3 hazardous materials in non-DOT specification bulk packaging aboard cargo-only aircraft. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.

b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.

- c. No party status will be granted to this special permit.
- 3. <u>REGULATORY SYSTEM AFFECTED</u>: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR § 172.101 Hazardous Materials Table Column (9B) and §§ 173.27, 173.242 and 173.243 in that the quantity limitation may not be exceeded and UN packaging is required, except as provided herein.
- 5. <u>BASIS</u>: This special permit is based on the application of J & M Alaska Air Tours, Inc. dated May 22, 2024, submitted in accordance with § 107.117 and the determination that it is necessary to protect life and property.

## 6. HAZARDOUS MATERIALS (49 CFR 172.101):

## 7. <u>SAFETY CONTROL MEASURES</u>:

### a. <u>PACKAGING</u>:

(1) Prescribed packaging is a non-DOT specification Bulk Aviation Transport Tank (BATT) Multi-Fuel Tank with a 476-gallon capacity, manufactured by SEI Industries Ltd., as described in J & M Alaska Air Tours, Inc.'s application dated May 22, 2024, and on file with the Office of Hazardous Materials Safety.

(2) For transportation the tank must be secured as cargo in a Cessna 208B Caravan or a Pilatus PC-12 aircraft that is registered to the grantee.

(3) The BATT must be maintained and inspected in accordance with the manufacturer's recommendations. The use of the tank must be within the confines and limitations outlined in the BATT Multi-Fuel Operations Manual.

### b. <u>OPERATIONAL CONTROLS</u>:

(1) Transportation is only authorized in remote areas of Alaska, when no other means of transportation is practicable.

(2) Authorized Persons Aboard Aircraft: No person may be carried on the aircraft other than the essential flight crew when transporting the HM in paragraph 6.

(3) Crewmembers will be briefed in detail as to the hazards of the material and in responding to any emergency related to the material aboard the aircraft while in flight.

(4) Annual hazardous materials training must include spill response, loading, unloading, and handling of bulk fuel.

(5) Training is required for handling tanks, hose setup, pump operation, and containment during the fuel transfer operation.

(6) All tanks, hoses, and pumps must be certified for the fuel being transferred.

c. <u>MARKING:</u> The packaging described in paragraph 7.a. above must be marked "DOT-SP 21783" in letters at least two inches high on a contrasting background.

## 8. <u>SPECIAL PROVISIONS</u>:

a. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package, and it is reoffered for transportation in conformance with this special permit and the HMR.

b. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.

c. This special permit does not grant authority to use Canadian or foreign-controlled airspace or airports outside the United States.

- 9. MODES OF TRANSPORTATION AUTHORIZED: Cargo-only aircraft.
- 10. <u>MODAL REQUIREMENTS</u>: A current copy of this special permit must be carried aboard each aircraft used to transport packages covered by this special permit. This special permit does not waive any FAA airworthiness requirements or the need to obtain other required FAA authorizations.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
  - All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.

- o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
- o Registration required by § 107.601 <u>et seq</u>., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) — "The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS</u>: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
