# DOT-SP 21846

## (FOR RENEWAL, SEE 49 CFR 107.109)

## 1. <u>GRANTEE</u>: (See individual authorization letter)

## 2. <u>PURPOSE AND LIMITATIONS</u>:

a. This emergency special permit authorizes the transportation in commerce of manufactured articles containing gallium. This special permit provides no relief from the Hazardous Materials Regulations (HMR) or the International Civil Aviation Organization's Technical Instructions for the Safe Transport of Dangerous Goods by Air (ICAO TI) other than as specifically stated herein. The most recent revision supersedes all previous revisions.

b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.

c. Unless otherwise stated herein, this special permit consists of the special permit authorization letter issued to the grantee together with this document.

d. This special permit serves as an "exemption" as defined in 1;3.1.1 of the ICAO TI and as a "Competent Authority Approval" as defined under 49 CFR § 107.1.

- 3. <u>REGULATORY SYSTEM AFFECTED</u>: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR § 173.162(c) and paragraph b) of Special Provision A69 of the ICAO TI in that manufactured articles may exceed more than 100 mg of gallium and the quantity of gallium per package may exceed 1 gram.
- 5. <u>BASIS</u>: This emergency special permit is based on the application of NVIDIA Corporation dated August 21, 2024, submitted in accordance with § 107.117 and the determination it is necessary to prevent significant economic loss.

## 7. <u>SAFETY CONTROL MEASURES</u>:

a. <u>PACKAGING</u>: The packaging must comply with Appendices A through C of the August 21, 2024, application on file with the Office of Hazardous Materials Safety (OHMS).

## b. <u>TESTING</u>:

(1) The packaging must be tested and pass the tests specified in Appendix D of the August 21, 2024, application on file with OHMS.

(2) The manufactured articles must be tested and pass the tests specified in Appendix G of the August 21, 2024, application on file with OHMS.

c. <u>OPERATIONAL CONTROLS</u>: Manufactured articles must conform to § 173.162(c) and Special Provision A69 of the ICAO TI except that each manufactured article may not contain more than 500 mg of gallium.

d. <u>MARKING</u>: Each package, and overpack if used, prepared under the provisions of this approval must be plainly marked with the special permit number. Packages prepared for retail sale are excepted from this requirement.

## 8. <u>SPECIAL PROVISIONS</u>:

a. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package and it is offered for transportation in conformance with this special permit, the HMR, and the ICAO TI.

b. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.

c. This special permit in no way affects the need to obtain any required authorizations from other agencies of the United States Government or from the competent authorities of the States of origin, transit, over flight, and destination of the consignment, as well as the State of the air operator.

- 9. <u>MODES OF TRANSPORTATION AUTHORIZED</u>: Motor vehicle, rail freight, cargo vessel, passenger-carrying aircraft, and cargo-only aircraft.
- 10. <u>MODAL REQUIREMENTS</u>: A current copy of this special permit must be carried aboard each cargo vessel, aircraft or motor vehicle used to transport packages covered by this special permit. The shipper must furnish a copy of this special permit to the air carrier before or at the time the shipment is tendered.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et seq</u>:
  - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
  - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
  - o Registration required by § 107.601 <u>et seq</u>., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) — "The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS</u>: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this

special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
