1. GRANTEE: Environmental Protection Agency Region 9
San Francisco, CA
2. PURPOSE AND LIMITATION:
 - a. This special permit authorizes the transportation in commerce of hazardous materials in support of recovery and relief operations from and within Los Angeles wildfire disaster areas (Eaton and Palisades Fires) under conditions that may not meet the Hazardous Materials Regulations. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
 - b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
 - c. No party status will be granted to this special permit.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR Parts 171-180 in that compliance with the HMR is required, except as specified herein.
5. BASIS: This special permit is based on the application of Environmental Protection Agency Region 9 dated February 25, 2025, submitted in accordance with § 107.105 and the determination that it is necessary to protect life and property.

7. SAFETY CONTROL MEASURES:

- a. Compliance with the HMR is required to the extent practicable. When compliance with the HMR is not practicable, shipments may be offered under alternative safety requirements imposed by the grantee.
- b. Specifically, hazardous materials must be segregated and transported utilizing appropriate safety practices to collection facilities designated by the grantee. Relief from HMR shipping paper and hazard communication requirements applies only to emergency packaging and segregation in disaster areas, up to the point hazardous materials are received at designated collection facilities.
- c. Vehicles loaded by field teams must utilize the Dangerous placard, load specific hazardous class placards, or both and will be escorted to collection facilities by grantee representatives.
- d. All applicable HMR provisions (including UN specification packaging, lab-pack requirements, hazard communication and shipping paper requirements) will apply after delivery to collection centers designated by the grantee.

8. SPECIAL PROVISIONS:

- a. Operations under this special permit are limited to Environmental Protection Agency Region 9 and persons conducting recovery and relief operations under the direction of Environmental Protection Agency Region 9 from and within disaster areas identified in (DR-4856-CA) issued by the Federal Emergency Management Agency.
- b. A current copy of this special permit should be maintained at the Incident Command Post (ICP) and staging areas.

9. MODES OF TRANSPORTATION AUTHORIZED: Highway

10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each motor vehicle used to transport packages covered by this special permit.
11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
 - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) —“The Hazardous Materials Safety and Security Reauthorization Act of 2005” (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term “exemption” to “special permit” and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in

writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
