1. <u>GRANTEE</u>: Suttons International Inc.

Holmdel, NJ

2. PURPOSE AND LIMITATION:

- a. To authorize the transportation in commerce of portable tanks that have be requalified using an alternative method. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
- b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
- c. No party status will be granted to this special permit.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. <u>REGULATIONS FROM WHICH EXEMPTED</u>: 49 CFR § 180.605(d) in that the internal visual is required, § 180.605(h)(1) in that leakage test must be at a pressure of at least 25% of MAWP and performed with either air or hydrostatic.
- 5. <u>BASIS</u>: This special permit is based on the application of Suttons International Inc. dated February 27, 2025, submitted in accordance with § 107.105 and the public proceeding thereon.

This special permit authorizes an alternative intermediate periodic test at the two-and-a-half-year interval. The portable tanks must be tested while filled with the hazardous material listed in paragraph 6 of this special permit in accordance with test procedure, ISHQ-F, Rev. 01 (2.5 Year Gas in Tank Test Procedure; UN3163 R1234ze Class 2.2), on file with the Office of Hazardous Materials General Approvals and Permits.

b. TESTING:

- (1) Leakage testing must be performed using the vapor pressure at ambient conditions at the time and date of test. All joints under pressure must be coated with or immersed in a solution of soap and water, heavy oil, or other material suitable for the purpose of detecting leaks. The leakage test hold time shall be at a minimum of fifteen (15) minutes.
- (2) The leakage testing of discharge valves for the liquid and gas lines and the pressure relief device (PRD) are waived.
- (3) The internal examination per §180.605(h)(d) is waived provided that no leakage occurred during the leakage test.
- (4) For verification of the PRD setpoint pressure during the test, the tell-tale gauge must be removed and a regulated nitrogen supply shall be used to pressurize the interstitial space between the burst disc and the PRD.

c. OPERATIONAL CONTROLS:

- (1) Portable tanks must be in dedicated service for the material listed in paragraph 6. of this special permit.
- (2) Portable tanks tested in accordance with the alternative intermediate periodic test authorized by this special permit must be marked in accordance with § 180.605(k)(1).

8. <u>SPECIAL PROVISIONS</u>:

- a. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package or its contents and it is reoffered for transportation in conformance with this special permit and the HMR.
- b. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.

- 9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle and cargo vessel.
- 10. <u>MODAL REQUIREMENTS</u>: A current copy of this special permit must be carried aboard each cargo vessel, or motor vehicle used to transport packages covered by this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
 - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
 - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
 - o Registration required by § 107.601 et seq., when applicable.

Each "Hazmat employee", as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) — "The Hazardous Materials Safety and Security Reauthorization Act of 2005" (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. <u>REPORTING REQUIREMENTS</u>: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety, in

writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
