1. GRANTEE: Amazon.com, Inc.  
Seattle, WA
2. PURPOSE AND LIMITATION:
  - a. This special permit authorizes the transportation in commerce of certain compressed gases (Argon, Carbon dioxide, Helium, and Nitrogen) in authorized cylinders with a capacity of no more than 1 liter as limited quantities. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
  - b. The safety analyses performed in the development of this special permit only considered the hazards and risks associated with the transportation in commerce.
  - c. No party status will be granted to this special permit.
3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 172.301(c) in that the special permit marking is not required; and 173.306(a)(1) in that compressed gases in containers exceeding 4 fluid ounce capacity are authorized to be transported as limited quantities.
5. BASIS: This special permit is based on the application of Amazon.com, Inc. dated July 18, 2025, and submitted in accordance with § 107.105 and the public proceeding thereon and additional information dated February 4, 2026.

6. HAZARDOUS MATERIALS (49 CFR 172.101):

7. SAFETY CONTROL MEASURES:

a. PACKAGING: Prescribed packagings are cylinders authorized under §173.302 with a maximum capacity of 1,000 mL (1 L) and have a maximum test pressure capacity of 15.2 MPa·L (152 bar·L).

b. OPERATIONAL CONTROLS:

(1) Cylinders authorized by this special permit shall not be packaged with other hazardous materials.

(2) Transportation by aircraft is not authorized.

c. MARKING: Each package transported under this special permit as a limited quantity shall be marked and transported in accordance with the requirements of DOT-SP 21607.

8. SPECIAL PROVISIONS:

a. A person who is not a holder of this special permit who receives a package covered by this special permit may reoffer it for transportation provided no modification or change is made to the package or its contents and it is reoffered for transportation in conformance with this special permit and the HMR.

b. A current copy of this special permit must be maintained at each facility where the package is offered or reoffered for transportation.

c. This special permit may only be used by the Amazon fulfilled network including third-party logistics providers that utilize Amazon’s hazardous materials classification system and customer fulfillment technologies in the Amazon Fulfillment Network; the special permit cannot be used by “third-party sellers” operating on Amazon’s website. Third-party logistics providers must only use this special permit for Amazon shipments.

9. MODES OF TRANSPORTATION AUTHORIZED: Motor vehicle, cargo vessel, ferry vessel and rail freight.
10. MODAL REQUIREMENTS: None required under this special permit.
11. COMPLIANCE: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 et seq:
  - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.
  - o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable.
  - o Registration required by § 107.601 et seq., when applicable.

Each “Hazmat employee”, as defined in § 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by §§ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when this special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) — “The Hazardous Materials Safety and Security Reauthorization Act of 2005” (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term “exemption” to “special permit” and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 - Immediate notice of certain hazardous materials incidents, and 171.16 - Detailed hazardous materials incident reports. In addition, the grantee(s) of this

special permit must notify the Associate Administrator for Hazardous Materials Safety, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
