

1. The Department of Defense, Washington, D.C., is hereby granted an exemption from certain provisions of this Department's Hazardous Materials Regulations to offer packages prescribed herein of a Class C explosive for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the transport of caseless ammunition, and provides no relief from any regulation other than as specifically stated.
2. BASIS. This exemption is based on the U.S. Department of Defense's application dated April 9, 1990, submitted in accordance with 49 CFR 107.105 and the public proceeding thereon.
3. HAZARDOUS MATERIALS (Descriptor and Class). Caseless 25MM ammunition, including the encapsulation subsystem, which has been specifically identified to and on file with the Office of Hazardous Materials Transportation (OHMT); Class C explosive.
4. PROPER SHIPPING NAME (49 CFR 172.101). Caseless ammunition, 25MM, with solid projectile, Explosive C.
5. REGULATION AFFECTED. 49 CFR 172.101, 173.89, 175.3.
6. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle and cargo-aircraft only.
7. SAFETY CONTROL MEASURES. Packaging prescribed consists of an inside fiberboard box with egg crate separations for each of the 50 rounds. Each fiberboard box must be sealed in an evacuated barrier bag and overpacked in a strong wooden box as indicated on Brunswick Corporation Drawing Nos. 300265 or 300308. Each round must contain no explosive composition other than the type and quantity shown in Appendix II, Table I of Brunswick Corporation's letter of December 4, 1972.
8. SPECIAL PROVISIONS. A copy of this exemption must be carried aboard each aircraft used to transport packages covered by this exemption.

9. REPORTING REQUIREMENTS. Any incident involving loss of contents of the package or packaging failure must be reported to the Office of Hazardous Materials Transportation as soon as practicable.

10. EXPIRATION DATE. May 31, 1992.
