

DOT-E 8668
(FIRST REVISION)

1. Millipore Corp., Bedford, Mass., is hereby granted an exemption from those provisions of this Department's Hazardous Materials Regulations specified in paragraph 5 below to offer packages prescribed herein of a flammable liquid for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the shipment of pyroxylin solution or hexane solution classed as a flammable liquid, in a non-DOT specification stainless steel drum of 20 liter capacity, and provides no relief from any regulation other than as specifically stated. Each of the following is hereby granted the status of a party to this exemption:

Sherwood Medical Industries, Inc., De Land, Florida - PTE-1.

2. BASIS. This exemption is based on Millipore Corporation's application dated June 10, 1981, submitted in accordance with 49 CFR 107.103 and the public proceeding thereon. The granting of party status is based on the following application submitted in accordance with 49 CFR 107.111 and the public proceeding thereon:

Sherwood Medical Industries, Incorporated's application dated
October 7, 1981.

3. HAZARDOUS MATERIALS (Descriptor and class). Pyroxylin solution or hexane solution, classed as flammable liquid.

4. PROPER SHIPPING NAME (49 CFR 172.101). Flammable liquid, n.o.s., or the specific chemical name, as appropriate.

5. REGULATION AFFECTED. 49 CFR 173.119, 175.3.

6. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle, rail freight, cargo-only aircraft.

7. SAFETY CONTROL MEASURES. Packaging prescribed is a non-DOT specification stainless steel drum, having a capacity of 20 liters, and constructed to meet A.S.M.E. UM Code. Specifications and other details of the drum - and the pipe plugs - must be as shown on Drawings XX6700P20D and YY1603150 (Part No. 001301 PP) furnished with petitioner's application. When the material being shipped is a flammable liquid mixture containing hexane, it must not be under pressure during transportation; and the stainless steel drum is overpacked in a box constructed of 3/4-inch thick plywood.

8. SPECIAL PROVISIONS.

a. Persons who receive packages covered by this exemption may reshipe them pursuant to the provisions of 49 CFR 173.22a.

b. A copy of this exemption must be carried aboard each aircraft used to transport packages covered by this exemption.

9. REPORTING REQUIREMENTS. Any incident involving loss of contents of the package must be reported to the Office of Hazardous Materials Regulation as soon as practicable.

10. EXPIRATION DATE. August 15, 1983.
