

ADVISORY

IF YOU ARE A HOLDER OF AN EXEMPTION THAT AUTHORIZES THE USE OF A PACKAGING WITH A MAXIMUM CAPACITY LESS THAN 450 L (119 GALLONS) OR A MAXIMUM NET MASS LESS THAN 400 KG (882 POUNDS), PLEASE BE ADVISED THAT YOUR EXEMPTION MAY NOT BE RENEWED BEYOND SEPTEMBER 30, 1996. IN ADDITION, NO NEW CONSTRUCTION OF PACKAGINGS WHICH FALL WITHIN THE NON-BULK CAPACITIES LISTED ABOVE ARE AUTHORIZED AFTER SEPTEMBER 30, 1994. THIS IS CONSISTENT WITH THE IMPLEMENTATION OF THE NEW PACKAGING REQUIREMENTS ADOPTED UNDER DOCKET HM-181. ANY APPLICATION SUBMITTED TO THIS OFFICE TO RENEW AN EXEMPTION BEYOND THE SEPTEMBER 30, 1996 DATE WILL BE DENIED UNLESS THE APPLICATION CONTAINS SUPPORTING INFORMATION TO JUSTIFY THE CONTINUATION OF THE EXEMPTION.

DOT-E 9513

1. American Cyanamid Company, Wayne, New Jersey, is hereby granted an exemption from those provisions of this Department's Hazardous Materials Regulations specified in paragraph 5 below to offer packages prescribed herein of a Class B poison for transportation in commerce subject to the limitations and special requirements specified herein. This exemption authorizes the transportation of an organic phosphate formulation in a bulk motor vehicle, and provides no relief from any regulation other than as specifically stated.

2. BASIS. This exemption is based on American Cyanamid Company's application dated September 10, 1985 submitted in accordance with 49 CFR 107.103, and the public proceeding thereon.

3. HAZARDOUS MATERIALS (Descriptor and Class). COUNTER 5G Soil Insecticide, classed as Poison B.

4. PROPER SHIPPING NAME (49 CFR 172.101). Organic phosphate.

5. REGULATION AFFECTED. 49 CFR 173.343 and 173.377.

6. MODES OF TRANSPORTATION AUTHORIZED. Motor vehicle.

7. SAFETY CONTROL MEASURES. Packaging prescribed is a bulk highway vehicle described in the application for exemption and shown on Drawings BKZ 1151 Rev. D dated 12/12/83, and BWZ 1396 dated 4-3-85.

8. SPECIAL PROVISIONS.

a. A copy of this exemption must be carried aboard each motor vehicle used to transport packages covered by this exemption.

b. Each cargo carrying body must be plainly marked on the right side near the front, in letters at least two inches high on a contrasting background, "DOT-E 9513".

9. REPORTING REQUIREMENTS. Any incident involving loss of contents of the package must be reported to the Office of Hazardous Materials Transportation as soon as practicable.

10. EXPIRATION DATE. October 31, 1987.
