2. PURPOSE AND LIMITATION:

- a. This special permit authorizes certain Dangerous Cargo Manifests (DCMs) to be retained in a location other than on or near the bridge of the cargo vessels owned or operated by Hapag-Lloyd AG while the vessels are in port. This special permit provides no relief from the Hazardous Materials Regulations (HMR) other than as specifically stated herein. The most recent revision supersedes all previous revisions.
- b. The safety analyses performed in development of this special permit only considered the hazards and risks associated with transportation in commerce.
- c. Party status will not be granted to this special permit.
- 3. REGULATORY SYSTEM AFFECTED: 49 CFR Parts 106, 107 and 171-180.
- 4. REGULATIONS FROM WHICH EXEMPTED: 49 CFR § 176.30(a) in that Dangerous Cargo Manifests are required to be kept on or near the bridge of the cargo vessel, except as provided herein.
- 5. BASIS: This special permit is based on the application of Hapag-Lloyd AG dated September 22, 2010, submitted in accordance with \$ 107.109 and additional information of October 14, 2011.

7. SAFETY CONTROL MEASURES:

a. OPERATIONAL CONTROLS -

- (1) While in a U.S. port, the DCM must be kept in the vessel's cargo office or other location on the vessel designated by the master of the vessel.
- (2) The location of the DCM must be readily accessible to emergency personnel.
- (3) A sign must be placed beside the designated holder on or near the vessel's bridge indicating the location of the DCM while the vessel is in port.
- 8. SPECIAL PROVISIONS: A current copy of this special permit must be maintained at each facility where DCM is located.
- 9. MODES OF TRANSPORTATION AUTHORIZED: Cargo vessel
- 10. MODAL REQUIREMENTS: A current copy of this special permit must be carried aboard each cargo vessel used to transport hazardous materials and produce DCM's under this special permit.
- 11. <u>COMPLIANCE</u>: Failure by a person to comply with any of the following may result in suspension or revocation of this special permit and penalties prescribed by the Federal hazardous materials transportation law, 49 U.S.C. 5101 <u>et</u> seq:
 - o All terms and conditions prescribed in this special permit and the Hazardous Materials Regulations, 49 CFR Parts 171-180.

- o Persons operating under the terms of this special permit must comply with the security plan requirement in Subpart I of Part 172 of the HMR, when applicable
- o Registration required by § 107.601 $\underline{\text{et seq.}}$, when applicable.

Each "Hazmat employee", as defined in \$ 171.8, who performs a function subject to this special permit must receive training on the requirements and conditions of this special permit in addition to the training required by \$\$ 172.700 through 172.704.

No person may use or apply this special permit, including display of its number, when the special permit has expired or is otherwise no longer in effect.

Under Title VII of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU)- 'The Hazardous Materials Safety and Security Reauthorization Act of 2005' (Pub. L. 109-59), 119 Stat. 1144 (August 10, 2005), amended the Federal hazardous materials transportation law by changing the term "exemption" to "special permit" and authorizes a special permit to be granted up to two years for new special permits and up to four years for renewals.

12. REPORTING REQUIREMENTS: Shipments or operations conducted under this special permit are subject to the Hazardous Materials Incident Reporting requirements specified in 49 CFR §§ 171.15 Immediate notice of certain hazardous materials incidents, and 171.16 Detailed hazardous materials incident reports. In addition, the grantee(s) of this special permit must notify the Associate Administrator for Hazardous Materials Safety -- OHMSPA, in writing, of any incident involving a package, shipment or operation conducted under terms of this special permit.
