


### Status of FY 2022 Grant Awards



37 entities were selected to receive \$196 million across 19 states.



# FY 2022 Applications and Awards

PHMSA received 179 NGDISM grant applications for FY 2022 with \$1.2 billion requested by applicants, which well exceeded the agency's available funding of \$196 million.

Due to the demand, PHMSA elected to implement a \$10 million cap so that more entities could receive funding. Additionally, PHMSA elected to cap all contingency costs to 10 percent.
