1.0 BUDGET NARRATIVE

The City of Carencro, Louisiana (hereafter referred to as “City of Carencro” or “City:”) submits this budget narrative in support of our form SF-424C.

A letter from the City’s auditor (Budget Narrative Attachment 1) provides information which demonstrates the City’s ability to perform activities associated with this application prior to reimbursement.

Budgetary costs were developed from past project histories, publicly available information and consultation with consulting and engineering firms.

The information in this Budget Narrative is derived from the Project Narrative for the City of Carencro which has been submitted separately.

The Sections below provide the Budget Narrative to support the cost categories from the SF-424C.

Administration and legal expenses

The City of Carencro expects only minimal administrative expenses and legal expenses. All work to be performed for this project will be subcontracted through an approved, qualified construction contractor and engineering firm. Administration and legal expenses would only consist of contract reviews by third party legal firm.

Currently, the City does not have the equipment, manpower (staffing), and expertise to self-perform construction activities of this project which is detailed in the accompanying Project Narrative. The City’s gas department consists of approximately four (4) full time employees some of which have other duties not related to the gas department. The City personnel will be available to provide institutional knowledge but not available to perform which on this project, therefore no reimbursable costs will be incurred by the City.

Land, structures, rights-of-way, appraisals, etc.

No costs associated with land, structures, rights of way or appraisals are anticipated for this project. The City of Carencro has existing utilities (water, sewer, and gas) in the current areas outlined for replacement of cast iron gas piping. Procurement of land and/or structure will not be required. All necessary rights of way are currently in place by the City. No appraisal will be required due to the fact that no structure currently exist in rights of way.

Relocation Expenses and Payments

The City of Carencro does not anticipate incurring any relocation expenses or payments. The project will take place in already established residential service areas where the City has right of way. Property owners may incur brief loss of gas, but this is not anticipated. Any temporary loss of gas supply to residents or businesses owners would be coordinated and occur at a time to ensure minimal to no impact to the owner.

Architectural and Engineering Fees

The City of Carencro will engage a qualified engineering firm experienced in gas distribution pipeline design, installation, mapping, surveying, as well as subsurface utility engineering to provide architect-engineer services for this project. This firm will have prior documented similar project experience as well as experience with city and Federal reimbursement projects. Professional services would include

those services that are required to be performed and certified by a licensed individual. Additionally, in accordance with 48 CFR 2.101, the proposed costs are associated with anticipated research, planning, development, design, and construction of the pipeline project.

The following activities are included with this cost classification:

- ◆ Preliminary Plans
- ◆ Final Plans
- ◆ Construction Administration
- ◆ Bid and Contract Services

Other architectural and engineering fees.

The City of Carencro will also engage a third-party inspector/auditor to ensure construction is compliant with all applicable standards for this project. This third-party inspector/auditor will also be responsible for reviewing all invoicing for project related costs to ensure compliance with the PHMSA NGDISM Grant guidelines.

The following activities are included with this cost classification:

- ◆ Topographic and property boundary surveys
- ◆ Construction design
- ◆ Utility coordination / subsurface engineering
- ◆ Right-of-way (ROW) stakeout for construction
- ◆ Coordination with existing utility companies
- ◆ Permits for Louisiana Department of Transportation and Development (LADOTD)

Project inspection fees

Costs associated with this field in the budget include the total anticipated costs of project inspection fees. The following activities are included with this cost classification:

- ◆ Photographs and videos
- ◆ Third party inspection

Site work

Site work to be done consists of the construction of natural gas distribution lines as replacements of cast iron pipe for the Owner's distribution system. It includes all trenching, backfilling, boring, drilling, pipe work, tie-ins, purging, testing, abandonment of replaced pipe, and all necessary appurtenances, as set out more fully in the project specifications. The work will include various sizes and lengths of lines at various locations within the City's pipeline system.

The following activities are included with this cost classification:

- ◆ Construction layout
- ◆ Temporary signs and barricades

- ◆ Contractor mobilization

Demolition and removal

Costs associated with demolition and removal will include:

- ◆ Repair/replacement of residential and business driveways
- ◆ Repair/replacement of concrete and/or asphalt streets
- ◆ Removal of cast iron piping
- ◆ Pulling and capping cast iron piping abandoned in place
- ◆ Landscaping

Construction

The City of Carencro has calculated the total cost of construction which includes:

- ◆ Gas main (2" PE)
- ◆ Gas main jack or bore (2" PE)
- ◆ Gas fitting (2" PE)
- ◆ Tie in to Existing (2" Steel)
- ◆ Service line (3/4" or 1" PE)
- ◆ Excess flow valve (3/4" or 1" PE)
- ◆ Service tap (2" main PE)
- ◆ Gas valve with cast iron box (2" PE)
- ◆ Installing new piping
- ◆ Stopples for tie-ins
- ◆ Boring activities
- ◆ Flaring of methane gas

Equipment

Because the City of Carencro will engage a subrecipient to fully conduct this project, the subcontractor will provide all the equipment necessary for project activities. The costs of equipment usage have been included in the total costs for the sitework, demolition and removal, and construction cost categories.

Contingencies

The City of Carencro has included costs to address project contingencies. With a project of this size and duration, and based on past-experience, the City's subcontractor recognizes there may be events or conditions that occur which are indeterminable at this. These contingencies have been limited to a specific percentage of the architectural and engineering fees, site work, and construction costs.

Contingencies would include:

- ◆ Increase in cost of construction materials such as piping and associated valves
- ◆ Increase in costs related to transportation of materials and supplies
- ◆ Unanticipated costs related to replacement of cast iron pipe due to unknowns (i.e., exact location, interference with other utilities, etc.)

2.0 PROCUREMENT OF PROPERTY AND SERVICES

The City does not anticipate purchase of any project equipment associated with this project, it intends to sub contract all engineering, construction, and site work. The City anticipates the schedule of completion of the project to be twenty-two (22) months. Activities will include replacement of cast iron piping with polyethylene (PE) piping through excavation and boring. Necessary pipeline infrastructure components would include pressure relief stations, regulator stations, excess flow valves, PE pipe, tracer wire and shut off valves.

3.0 OBJECT CLASS CATEGORIES

Currently, the City does not have the equipment, manpower (staffing), and expertise to self-perform construction activities of this project which is detailed in the accompanying Project Narrative. The City's gas department consists of approximately four (4) full time employees some of which have other duties not related to the gas department. The City personnel will be available to provide institutional knowledge but not available to perform which on this project, therefore no reimbursable costs will be incurred by the City.

4.0 FUNDING RESTRICTIONS

The City has reviewed and will abide by the various funding restrictions regarding costs that are not eligible for reimbursement under the FY 2022 NGDISM Grant Program.
