The City of Graysville will fully comply with all policies, recommendations, and mandates of the 2021 Infrastructure Investment and Jobs Act ("IIJA"), Pub. L. No. 117-58, which includes the Build America, Buy America Act ("the Act"). Pub. L. No. 117-58, §§ 70901-52. The Act strengthens Made in America Laws to bolster America's industrial base, protect national security, and support high-paying jobs. As such, Graysville will work to ensure that "none of the funds made available for a Federal financial assistance program for infrastructure, including each deficient program, may be obligated for a project unless all of the iron, steel, manufactured products, and construction materials used in the project are produced in the United States."

MIAO aims to increase reliance on domestic supply chains and reduce the need for waivers through a strategic process aimed at: achieving consistency across agencies; gathering data to support decision-making to make U.S. supply chains more resilient; bringing increased transparency to waivers in order to send clear demand signals to domestic producers; and concentrating efforts on changes that will have the greatest impact.

Per this policy, Graysville will ensure compliance with section 70914 of the Act, including by the incorporation of a Buy America preference in the terms and conditions of each award with an infrastructure project. Buy America preference will be made in the purchase and procurement processes to ensure:





The map on page 4 provides an overview of the lines and stations that will be impacted by this project and the itemized budget details the components that will be utilized. As such, Graysville is requesting \$5,032,493 in grant funds to replace 10 miles of deteriorating cast iron gas pipelines owned and operated by the Graysville Municipal Gas System.

a-Project Location

Graysville, AL, is a city about 13.2 miles from Birmingham. It is located along I-22 and connects with AL HWY 78. The current poverty rate for Graysville is 16.3%, and our employment rate is a mere 44%. Meanwhile, Graysville meets the RAISE definition for Area of Persistent Poverty and meets classifications for Historically Disadvantaged, Transportation Disadvantaged, Economically Disadvantaged, and Environmentally Disadvantaged (Jefferson County Census Tract 121.04). Graysville has a total population of 1,950; 28% of our population is black or African American, 66% is white, 3% is Hispanic, 5% are two or more races, and 2% are other. Only 16% of our residents have a bachelor's degree or higher, and 24% of our population is classified as disabled.

c-Project Eligibility

Originating in the late 1800s and early 1900s, the City of Graysville, Alabama, was incorporated in 1945. It was originally called Gin Town because it had the only cotton gin for miles. Local coal mines and steel mills attracted growth in the 1950s and 1960s, but recent economic downturns have significantly impacted jobs and economic development. During the 1980s and 1990s, Graysville expanded its city limits by annexing multiple acres in what was then unincorporated Jefferson County. Our population is less than 2,000 and we are like many small towns in that we often find ourselves between a rock and a hard place as we work to provide infrastructure and services with a severely limited tax base. Recent census data indicates that our poverty rate is 17.3%. The COVID-19 Pandemic has given us hardship after hardship, including losing the town's biggest employer, the Lowes store. Before the closing of Lowes, our 40.8% employment rate was significantly lower than the state (54.7%).

The City of Graysville is the applicant for this program and will be responsible for completing all elements of the proposed project.

d-Project Funding

Graysville is requesting \$5,032,493 in grant funds to replace 10 miles of deteriorating cast iron gas pipelines owned and operated by the Graysville Municipal Gas System. No other grant funds have been secured for this project, and there are currently no other pending applications for any of the components described in this application. It has been mandated that all cast iron infrastructure must be replaced by 2025. In recent years, Graysville has replaced 60 miles of the 70 miles of cast iron gas lines throughout our service region. Unfortunately, our city was dealing with extreme financial difficulties prior to the COVID-19 Pandemic, as we have been

continuously asked to do more with less. The pandemic provided Graysville with economic blow after blow. We have persevered and continue to work to address the needs of our residents. Yet rising prices in recent years combined the current realities of inflation, prevent us from replacing the remaining 10 miles of cast iron lines. Subsequently, we are desperately need funding to comply with the 2025 mandate, but most importantly, to address the safety and well-being of our community.

The original cast iron gas pipelines that transverse Graysville were installed in the 1940s-1960s. We are requesting PHMSA's assistance to replace the remaining 10 miles or so of gas infrastructure at an estimated cost of \$503,250 per mile.

4-Detailed Project Description

a-Summary of Work

The Graysville Municipal Gas System will replace 10 miles of deteriorating and crumbling cast iron gas pipelines in our community. To minimize the environmental impact of this project, the new lines will be "bored in" next to the existing lines through directional drilling. As such, we anticipate minimal excavating and minimal surface demolition and repair. The new lines will be the recommended polyethylene (PE). The station equipment, for all six stations in Graysville, will also need to be replaced to regulate the flow of gas distribution throughout the system. The current regulator systems are also comprised of cast iron and will not be able to withstand the increased pressure requirements of the new lines. Additionally, the station equipment in these stations is the original equipment installed in the 1960's. This equipment and lines are obsolete (have not been manufactured for several decades) and no parts are available for repairs. The current regulator pilots at these stations have issues of "continual bleed to atmosphere" and subsequently need to be repaired to operate. Therefore, this infrastructure needs to be replaced in order to comply with PHMSA Section 114. Work at these stations will include replacing two (2) 2" gas regulator / monitor runs with 4" inlet and outlet piping, one (1) 2x3 relief valve and inservice connections (hot-taps) to existing 4" high-pressure inlet piping and 6" medium- pressure outlet piping. The project will also include the abandonment and removal of existing station piping and modifications to the fencing and site area.

b-Safety Risk Profile

The cast iron gas lines in Graysville were installed from the late 1940s through the 1960s and to state that they need to be replaced would be an understatement. We have replaced what we could, but we still have 10 miles of line that desperately need to be addressed. We fear that the current system is a ticking bomb that could possibly devastate our community. In its current state, the Graysville gas system is plagued with problems and leaks, as summarized in the following table:

Graysville Average Annual Gas Leaks

Grade 3: 100+ per year Grade 2: 30-40/year Grade 1: 5-10 most years There have been several serious incidents with similar cast iron pipelines in recent decades which have caused a "resurging attention to the risks associated with cast and wrought iron pipelines." Iron pipe is fraught with issues, from earth movement to degradation and the higher pressures that occur when old lines and connections meet new lines can have disastrous consequences. Ongoing budget shortfalls and continued economic downtowns have forced Graysville to continuously do more with less. Our citizens haven't fared much better as many employers have left our community even more economically challenged. As a result, we are relying on band-aid fixes that only delay the inevitable.

"Aging pipes are a high-risk example of the nation's struggle to replace its crumbling infrastructure, a danger hidden beneath the ground until a pipe fails or is struck by something, and a spark ignites a monstrous blast. Natural gas is piped into 67 million homes and at least 5 million businesses, schools and other buildings across the country, with gas distribution and service lines snaking beneath most neighborhoods in American cities. Leaking gas accumulating in buildings, basements and crawl spaces — if ignited — can explode with a force akin to a small but concentrated earthquake. The rapidly expanding pressure can blow out windows, roofs and support beams, collapsing buildings in an instant." https://www.usatoday.com/story/news/nation/2014/09/23/gas-pipes-cast-iron-deaths-explosions-investigation/15783697/

For several years, it has been argued that "aging pipes are a high-risk example of the nation's struggle to replace its crumbling infrastructure, a danger hidden beneath the ground until a pipe fails or is struck by something and a spark ignites a monstrous blast." A similar instance occurred in gas pipeline in Marengo County, Alabama back in April 2022. This incident caused great concern throughout our community given our similar infrastructure elements. While not unique to our region, we desperately need to address this issue before we have a catastrophic event in our community. It is also important to note that Graysville's close proximity to Birmingham combined with our location along I-22 and AL HWY 78, could be particularly troubling in the event of a line failure, distributing traffic, impacting the environment, and having a greater impact on the safety and well-being of the region as opposed to being isolated to our community.

"Alabama has 6,748 miles of interstate pipeline, plus more than 57,000 miles of smaller main and service lines that distribute product from a transmission pipeline. By comparison, Mississippi has 10,450 miles of interstate pipe, and Arkansas has 7,212 miles."

An incident in Shelby County, Alabama back in 2016 had folks in the region sounding the alarm for the public and government action regarding the ongoing threats of the gas pipelines throughout our state. It was argued that our cast iron lines were a ticking time bomb waiting to explode as indicated by the fact that our state had already had more than 68 "significant"

incidents" in the past couple of decades. Yet six years later, small communities like Graysville are still desperately seeking solutions to diffuse the issues with deteriorating infrastructure.

Cast iron pipes are prone to leaks and failure "but they are also vulnerable to overpressure", which is often the case in explosions and similar incidents with gas systems throughout the country. "In order to deliver gas to customers, it must be compressed to a certain pressure. There are protections in place to prevent overpressure (e.g., pressure regulators), but those protections can fail. A

pressure surge into aging pipeline can easily result in a leak or catastrophic failure." Oftentimes, a "devastating chain of fires are caused by over-pressurization in the gas lines." Graysville is particularly concerned about pressure issues and the integrity of our system as our regulator stations are all over 60 years old. Moreover, the stations are comprised of obsolete equipment that need parts that are no longer available, forcing us to continue utilizing the "band-aid fix" approach until we secure funding for the needed upgrades.

"The National Transportation Safety Board (NTSB) and the Pipeline and Hazardous Materials Safety Administration have been warning utilities that these aging pipelines need to be replaced" but unfortunately but "the cost of replacing these pipelines can exceed more than \$1 million a mile, with the costs passed on to consumers." Despite our best efforts, neither the city of Graysville nor our customers have the resources to replace the crumbling cast iron pipes without the proposed grant funding. We are a poor rural community characterized by low household incomes and socially disadvantaged populations.

Moreover, Alabama sees more than its fair share of tornados and we fear that one catastrophic event could lead to the complete devastation of our region should a natural disaster impact lines connected to Graysville's cast iron infrastructure. "Graysville, AL is a Very High Risk area for tornados" with an average of 3 tornados per year. Needless to say, the EF-1 tornado near Graysville back in January caused considerable alarm as it crossed I-22 and Lynns Crossing Rd. While we cannot prevent tornados from impacting our community, the proposed project will make our infrastructure considerably more stable in the event of a disaster.

c-PHMSA's Environmental Review

Graysville recognizes that the current state of this infrastructure is a significant environmental concern as the crumbling lines are prone to continual leaks and are constantly leaching gas into the environment. Graysville will fully comply with PHMSA in the completion of all Environmental Assessments (Tier 1 and Tier 2) associated with this project. Our priority with this project is to replace the antiquated cast iron gas pipelines to ensure the safety of our residents while also reducing the environmental impact of this infrastructure upon our community. We will work closely with PHMSA and all other federal and state agencies to mitigate the impact of this project (including the utilization of heavy equipment) and the full compliance with all applicable regulations, policies, guidelines, and best practices will be a required element of the bidding and contractual process for work on this project.

Through the proposed pipeline project, contractors will be selected through a competitive bid process, and environmental mitigation will be included in the bid criteria. One of this project's goals is to reduce the environmental impact of our gas pipeline infrastructure. Graysville will work with the PHMSA, the AL Gas Pipeline Safety Section, Alabama Department of Environmental Management (ADEM), and all other applicable agencies in the completion of the environmental analysis Tier 1 and Tier 2. The City's administrative team will coordinate with all state and federal regulatory agencies. All environmental certifications and approvals will be obtained within the first three to six months after the grant is awarded.

d-Compliance with Civil Rights Act, Section 504

5-Statement of Authority and Pipeline Infrastructure Safety and Modernization Capabilities

The Graysville Water and Gas Utility provides water and natural gas to the Graysville and Adamsville areas and natural gas service to the Forestdale and Docena areas. The Utility is owned by the City of Graysville Alabama and operated by the Graysville Water Board and by the Graysville Municipal Gas System. The Graysville Municipal Gas System has been in operation since 1949. After the great depression of the 1930s, the City of Graysville was incorporated November 27, 1945. The first meeting of the town council took place on January 16, 1946. Later that year the original city council established the Graysville Water Works system. In 1949, the city council made the bold move to establish the Graysville Gas Board that would eventually become the Graysville Municipal Gas System.

6-Projected Outputs and Objectives

Project Goal: To update and modernize the gas infrastructure in Graysville Alabama by February 2026.

Output Criteria #1: Safety

In recent years, Graysville has averaged over 100 Grade 3 and 30-40 Grade 2 incidences per year. But most alarmingly, we are having 5-10 Grade 1 incidences per year. Needless to say, we have much to be concerned about as a single spark near these breaks would be absolutely devastating. Our number one priority with this project is to improve the safety of our gas delivery system.

Objective 1.1: The Graysville Municipal Gas System will eliminate its use cast iron pipelines by replacing this infrastructure with PE pipes by Dec 2025, as measured by invoicing, reports and repair logs.

Output: Use of cast iron pipes replaced by recommended PE pipes.

Objective 1.2: The Graysville Municipal Gas System will significantly reduce the number of incidences by February 2026, as measured incident report data.

Outputs: Significant reductions in Grade 3, Grade 2, and Grade 1 incidences in all years following the completion of the project

Output Criteria #2: Environment

The current state of this infrastructure is a significant environmental concern as the crumbling lines are prone to continual leaks and are constantly leaching gas into the environment. Graysville will fully comply with PHMSA in the completion of all Environmental Assessments (Tier 1 and Tier 2) associated with this project. Our priority with this project is to replace the antiquated cast iron gas pipelines to ensure the safety of our residents while also reducing the environmental impact of this infrastructure upon our community.

Objective 2: The Graysville Municipal Gas System will significantly reduce and/or eliminate incidences of gas leakage and environmental concerns by February 2026, as measured by incident reports, environmental assessments, and repair logs.

Outputs:

- Use of cast iron pipes replaced by recommended PE pipes.
- Reduction in gas leaks from the system
- Significant reductions in Grade 3, Grade 2, and Grade 1 incidences in all years following the completion of the project
- Since the new system will not be plagued with leaks and other environmental degradation concerns, the proposed gas system upgrades will be better for the environment.

Output Criteria #3: Job Creation

We anticipate that this project will create at least 2 jobs for the duration of this project through our work with contractors associated with this project.

Objective 3: The Graysville Municipal Gas project will hire a contractor by July 2023 who will employ at least 4 workers who will work on this project.

Output Criteria #4: Equity

Unfortunately, Graysville is the worst of the worst regarding poverty and disadvantage. Meanwhile, Graysville meets the RAISE definition for Area of Persistent Poverty and meets classifications for Historically Disadvantaged, Transportation Disadvantaged, Economically Disadvantaged, and Environmentally Disadvantaged (Jefferson County Census Tract 121.04). Graysville has a total population of 1,950; 28% of our population is black or African American, 66% is white, 3% is Hispanic, 5% are two or more races, and 2% are other. Only 16% of our residents have a bachelor's degree or higher, and 24% of our population is classified as disabled.

Graysville is actively working to bring industry and jobs to our community. These efforts have resulted in 100 new jobs through the Truckworx Company, a new B.P. service station, and additional restaurants. We anticipate that this improvement in infrastructure will enhance our ability to recruit businesses and industry to our community.

7-Project Implementation and Management

The proposed project will be administered by the City Graysville and Graysville Municipal Gas Services. Upon grant award, we will work with PHMSA and the Alabama Department of Environmental Management (ADEM) to complete all required environmental assessments. Project work will be contracted through a competitive bidding process and full compliance with all applicable federal, state, and local regulations, policies, and recommendations, including the "Blue Book for Gas Service" will be a requirement of all contracted services.

A scoring rubric will be created to assist in the assessment of bids and contract bids will be reviewed by both the City Council and the Gas and Water Board to determine the best and most cost-effective applicant to complete this project while adhering to all applicable laws, regulations, policies, and best practices. To further ensure the success of this project, Heath Whitworth, the Field Supervisor for the Gas and Water Board, will oversee all aspects of this project and all contractors and all activities of this project.

8-Explanation of Evaluation and Selection Criteria Equivalence

Summary of Technical Elements

Project Scope:

The Graysville Municipal Gas System will replace 10 miles of deteriorating and crumbling cast iron gas pipelines in our community. To minimize the environmental impact of this project, the new lines will be "bored in" next to the existing lines through directional drilling. As such, we anticipate minimal excavating and minimal surface demolition and repair. The new lines will be the recommended polyethylene (PE). The station equipment, for all six stations in Graysville, will also need to be replaced to regulate the flow of gas distribution throughout the system. The current regulator systems are also comprised of cast iron and will not be able to withstand the increased pressure requirements of the new lines. Additionally, the station equipment in these stations is the original equipment installed in the 1960's. All of this equipment is obsolete and as such, the parts needed for the maintenance and repair of these systems have not been manufactured for several decades. The regulator pilots at these stations have issues leading to "continual bleed to atmosphere." Therefore, these regulators desperately need to be replaced in order for the Graysville Gas System to operate in compliance with PHMSA Section 114. The work at these stations will include replacing two (2) 2" gas regulator / monitor runs with 4" inlet and outlet piping, one (1) 2x3 relief valve and in-service connections (hot-taps) to existing 4" high-pressure inlet piping and 6" medium- pressure outlet piping. The project will also include the abandonment and removal of existing station piping and modifications to fencing as well as additional needed site repair to ensure the safety and integrity of this system.

Additionally, Heath Whitworth, the Field Supervisor for the Gas and Water Board, serve as the Project Director and will provide oversight for this project and will provide regular progress updates to the Mayor's office and City Council.

Non-discrimination:

The City of Graysville policy prohibits discrimination on the basis of race, color, sex, religion, creed, age, and national origin. Additionally, the City of Graysville and its entities are fully

compliant with all requirements under Title VI of the Civil Rights Act, Section 504 of the Rehabilitation Act, and their implementing regulations, including 28 CFR. The proposed project will operate in full compliance with these regulations as well as contractors working on behalf of the City of Graysville.

Environmental Assessment:

As previously discussed, Graysville will fully comply with PHMSA in the completion of all Environmental Assessments (Tier 1 and Tier 2) associated with this project. Our priority with this project is to replace the antiquated cast iron gas pipelines to ensure the safety of our residents while also reducing the environmental impact of this infrastructure upon our community. We will work closely with PHMSA and all other federal and state agencies to mitigate the impact of this project (including the utilization of heavy equipment) and full compliance with all applicable regulations, policies, guidelines, and best practices will be a required element of the bidding and contractual process for work on this project.

Budget Summary

This process will include directional drilling to "bore in" new lines parallel to the current cast iron lines and replacing the 60-year-old components of 6 regulator stations. 11-Critial Infrastructure Security and Resilience

Graysville has been cognizant of our town's needs to maintain the security and resilience of our critical infrastructure since the horrific events of 9-11. As such, we make every effort to ensure that the safety and security of ALL infrastructure elements in our community. All city workers are regularly trained to watch for potential threats, our citizens are encouraged to report suspicious activity and our first responders are continuously at the ready. Law enforcement regularly patrol the community, including areas containing potentially exposed critical infrastructure. City personnel have attended various threat mitigation and homeland security training sessions and the Fire Department regularly provides additional inspection services of these elements, including our gas pipelines. Moreover, Graysville has established numerous safety protocols and procedures to further ensure the integrity of our systems and our response in the event of an emergency.


12-Environmental Analysis


a-Project Description and Location

The City of Graysville, Alabama (Graysville) is requesting funding for the Graysville Municipal Gas System. This utility was established by the city in 1949, and it later became the Graysville Municipal Gas System. Considered to be state of the art 70 years ago, the cast iron gas lines are rapidly deteriorating. Graysville's gas system serves 4,500 customers and despite the city's work to upgrade the lines in recent years, over 10 miles of cast iron lines desperately need to be replaced. In addition to replacing the lines, six regulator stations in the system will be updated to eliminate the remaining cast-iron elements in the system and to regulate the flow of gas throughout the infrastructure to ensure safety and to eliminate environmental concerns.

c-Property Changes

The proposed project will utilize the existing utility right away as new lines will be installed adjacent to existing lines so that there will be no changes in the vicinity of the lines. There will be some disturbance as the new lines are installed but this construction process will be relatively minimal in its net impact. There will be no foreseeable property changes during this process.

d-Wetlands

N/A. The proposed project will not impact wetlands as we update the gas infrastructure in Graysville.

e-Threatened and Endangered Species

N/A. The proposed project will not impact threatened and endangered species.

f-Floodplains.

The portions of Graysville that have been identified as 100-year floodplains are identified in the following graphic. The proposed project is not anticipated to transect any of these areas. However, all project activities will work to mitigate any potential issues and should any gas within the Graysville Municipal Gas district, impact property identified by FEMA as a floodplain, all upgrades with be consistent with the Federal Flood Risk Management Standards in Executive Order 14030, Climate-Related Financial Risk (86 FR 27967) and 13690, as we comply with all regulations regarding Establishing a Federal Flood Risk Management Standard and a Process for Further Soliciting and Considering Stakeholder Input (80 FR 6425).

Additionally, to further ensure flood mitigation and the environmental impacts of storm water runoff, Graysville is currently a member of Storm Water Management Authority, Inc. (SWMA) which has a membership of 21 cities within Jefferson County. The Alabama Department of Environmental Management (ADEM) is responsible for issuing the permits in Alabama as well as inspecting municipal storm sewer systems. The duration of each permit is five years. And SWMA helps the member cities cost share many of the requirements of the permit. The Components of the permit are as follows:

Public Education and Public Involvement on Storm Water Impacts
Illicit Discharge Detection and Elimination (IDDE) Program
Construction Site Storm Water Runoff Control
Post-Construction Storm Water Management in New Development and Redevelopment
Pollution Prevention/Good Housekeeping for Municipal Operations


Every year Graysville submits an Annual Report to ADEM and citizens are regularly reminded to contact City Hall regarding:


- An unknown liquid entering a stormwater drain, stream or river.

The Imperative Need for Gas Distribution Infrastructure Safety in Graysville, AL

Recent issues with similar gas pipelines (some in an arguably better condition than those in our community) have made the City of Graysville increasingly more alarmed regarding the potential for devastating consequences if our crumbing gas infrastructure is not addressed. Due to continued budget shortfalls and exponentially increasing inflation, our little community does not have the resources to address the needs of the gas distribution infrastructure without the proposed grant funding. Subsequently, we implore the DOT and PHMSA to support the proposed project as we replace cast iron pipelines and equipment that are over 60 years old. In addition to greatly improving the safety of this system, the proposed improvements will tremendously benefit the environment in our region as we work to eliminate leakage and leaching that are unfortunately inherent in our current system.
