Dear Mr. Forbes:

This letter is in response to your January 4, 2024, email requesting clarification of the Hazardous Materials Regulations (HMR; 49 CFR Parts 171-180) applicable to the ground clearance for Department of Transportation (DOT) Motor Carrier (MC) 300 series cargo tanks. You ask whether the landing gear and other attachments—under the reserved regulations for DOT MC 300 series cargo tanks (previously § 178.340-8(d)(2))—are considered components and/or protective devices that must maintain the minimum road clearance requirement of 12 inches.

The answer is yes. It is the opinion of this Office that, as it applies to DOT MC 300 series cargo tanks and the road clearance requirements specified in reserved § 178.340-8(d)(2), the landing gear and other attachments described in your email would be considered components of a DOT MC 300 series cargo tank and would require the minimum road clearance of 12 inches.

l am requestion a written interpretation in reference to the Hazardous Materials Regulations (HMR; 49 CFR Parts 171-180) and superseded regulations in Part 178.340 pertaining to ground clearance on MC-307, 307 & 312 and DOT 406, 407 & 412 Cargo Tank Motor Vehicles.

The superseded regulations for the 300 series cargo tanks in question state:

178.340-8(d)(2) Minimum road clearance: The minimum allowable road clearance of any cargo tank component or protective device located between any two adjacent axles on a vehicle or combination shall be at least one-half inch for each foot separating such axles and in no case less than 12 inches.

The current regulations 400 series in question state:

178.345-8(a)(5) Minimum road clearance. The minimum road clearance of any cargo tank motor vehicle component or protection device located between any two adjacent axles on a vehicle or vehicle combination must be at least one-half inch for each foot separating the component or device from the nearest axle of the adjacent pair, but in no case less than twelve (12) inches, except that the minimum road clearance for landing gear or other attachments within ten (10) feet of an axle must be no less than ten (10) inches. These measurements must be calculated at the gross vehicle weight rating of the cargo tank motor vehicle.

The superseded regulations state "cargo tank component" and the current regulations stated "cargo tank motor vehicle component". The terms are not defined in the regulations and this has caused some confusion. The current regulations are quite clear on landing gear and other attachments.

Q. For the superseded regulations (300 Series) are landing gear and other attachments considered a cargo tank component and must have at least12 inches road clearance per the regulations or are they not a cargo tank component and not included in the calculation of road clearance for 300 series tanks.
