

U.S. Department of Transportation Pipeline and Hazardous Materials Safety Administration

2016 Annual Civil Penalty Report

The Pipeline and Hazardous Materials Safety Administration (PHMSA), Office of Hazardous Materials Safety (OHMS) has processed 42 cases and 256 tickets in calendar year 2016. A summary of all the tickets and cases closed in 2016 are provided in the table below. These actions resulted in the collection of \$941,404 in fines.

Every year the OHMS Hazmat Field Operations staff verifies compliance with the safety and training standards of the Hazardous Materials Regulations by inspecting companies and individuals who offer hazardous materials for transportation or manufacture, maintain, repair, recondition or test packages authorized for transporting hazardous materials.
