Dear Mr. Connell:

This letter is in response to your October 26, 2023, email requesting clarification of the Hazardous Materials Regulations (HMR; 49 CFR Parts 171-180) applicable to packages (*i.e.*, boxes) of “UN1263, Paint (*including paint, lacquer, enamel, stain, shellac solutions, varnish, polish, liquid filler and liquid lacquer base*), 3, PG III” that are palletized and listed on a shipping paper. You state a carrier has informed you that a shipping paper must include the number of boxes containing “UN1263” on the bill of lading (*i.e.*, shipping paper). You are uncertain of the carrier’s understanding and reference a letter of interpretation (Reference No. 09-0158), which you believe has broader applicability and allows the use of “pallet” or “PLT” as the description of the type of package on a shipping paper. Specifically, you ask whether in your scenario the shipping paper must include the number of boxes along with the number of pallets in accordance with § 172.202(a)(7). You also provided a copy of the shipping paper in question for review.

Based on the information and copy of the shipping paper you provided, the shipping paper must include the type of package used to contain the “UN1263” material. A pallet (“PLT”) is not an acceptable package type for this material. A skid or pallet is commonly considered an overpack and not a package type in accordance with the HMR (*see* § 171.8).

In accordance with § 172.202(a)(7) of the HMR, the number and type of packages must be indicated on a shipping paper (*e.g.*, 12 boxes). Therefore, the number and type of packages for “UN1263” for each pallet must be documented on a shipping paper; however, the number of pallets does not need to be indicated. For example, an entry on a shipping paper for “UN1263” may be listed as:

- UN1263, Paint, 3, PG III, 12 boxes, 271 lbs.

Regarding Reference No. 09-0158, it addresses a unique packaging authorization applicable to wet batteries (“UN2795”). Specifically, § 173.159(d)(1) authorizes electric storage batteries secured on skids or pallets as an authorized non-specification packaging. In that scenario, it is acceptable for the person to indicate “1 skid” or “1 pallet” as the package type on the shipping paper because of the requirements found in § 173.159(d)(1).

Good morning, I have an issue coming from a transport carrier regarding this bill of lading.

First, the carrier is stating that the number of "boxes" must be listed on the attached. Looking at rule interpretation 09-158 it states that the term Pallet or "PLT" which is the package type listed on the US Government Bill of lading is wrong.

I want to make sure that I am interpreting this rule correctly as it pertains to this shipment.

Each pallet has the total hazardous material quantity listed in liters. That is per pallet.

So, my actual question is does the number of boxes or drums or packaging's have to be listed on top of the pallet amount being listed as well?

On top of that each pallet has the number of kits or KT listed in the description.

I just want to figure out if you the Department of Transportation regards this bill of lading as compliant with 49CFR 172.202(a)(7) as written.

I believe that the rules being cited in the email attachment are being mis-interpreted.

My background in HAZMAT shipping is extensive. I am a certified instructor who in my previous position instructed hundreds of people at an ammunition plant that ships class 1 explosives around the world.

I want to make sure that the rule interpretation I have cited above is applicable to this shipment. The reason that I believe that it is. Is because these rule interpretations are meant to be applied broadly across a wide range and not specifically to the type of Hazardous Materials listed.

I sincerely appreciate your help in resolving this matter as our mission is to get these supplies delivered to the war fighter.

Good afternoon. I am sorry that I missed your call.

Your example here... "No, including the number of packages on the pallet is not required. Generally, an indication of a "skid" or "pallet" as a package type on a shipping paper is prohibited because skids and pallets are typically considered overpacks and not packages under the HMR. However, § 173.159(d)(1) authorizes electric storage batteries firmly secured to a skid or pallet, and § 173.159(d)(2) authorizes electric storage batteries firmly secured to a skid as types of packaging for alkali batteries packed without other materials provided the requirements of § 173.159(a) are met. For transportation by aircraft, the requirements of § 173.159(b) also apply."

Yes, skid or pallet is approved as container for non-spillable batteries.

The BOL you sent over the first NSN

013023607 EPOXY COATING KIT. Packaging type cannot be skid or pallet. Is this in a drum or box? A pallet or skid will not suffice here.

172.202(a)(7).

"The number and type of packages must be indicated. The type of packages must be indicated by description of the package (for example, "12 drums"). Indication of the packaging specification number ("1H1") may be included in the description of the package (for example, "12 1H1 drums" or "12 drums (UN 1A1)"). Abbreviations may be used for indicating packaging types (for example, "cyl." for "cylinder") provided the abbreviations are commonly accepted and recognizable" SKID or Pallet is NOT acceptable in this instance for they are not "electric storage batteries"

A1 from your DOT rule interpretation pulls from 173.159(d) which falls § 173.159a Exceptions for non-spillable batteries.
